

- 1. Subsection (119) entitled "Ward 119" of Geotion 15.02 entitled "Wards and Ward Boundaries" of the Madison General Ordinances is hereby repealed.
- 2. Subsection (109) entitled "Ward 109" of Section 15.02 entitled "Wards and Ward Boundaries" of the Madison General Ordinances is amended to read as follows:
- "(109) Ward 109. Commencing at the SE corner of Section 15, T7N, R8E, Town of Middleton, Dane County, Wisconsin; thence along the South line to said Section 15, S89°12'22"W 1134.47 feet to a point that is 181.5 feet east of the West line of the SE 1/4 of the SE 1/4 of said Section 15 and the point of beginning; thence continuing along the South line of said Section 15, S89°12'22"W, 520.04 feet; thence N00°47'12"W, 281.00 feet; thence S89°12'22"W, 120.00 feet; thence S00°47'12"E, 281.00 feet to the South line of the SW 1/4 of said Section 15; thence west along the South line of said Section 15, S89°12'22"W, 464.60 feet 120.00 feet; thence N00°50'31"W,
