

Ordinance #390

An Ordinance Annexing Territory. To the City of Eagle River, Wisconsin

The Common Council of the City of Eagle River, Wisconsin, does hereby ordain as follows:

SECTION 1. **Territory Annexed.** In accordance with sec. 66.0217 of the Wisconsin Statutes and the petition for direct annexation filed with the City Clerk on the 15th day of April, 2002, signed by all of the electors residing in the territory to be annexed, the following described territory, in the Town of Lincoln, Vilas County, Wisconsin, is annexed to the City of Eagle River, Wisconsin:

A parcel of land being a part of Lots 72 & 73 of Oliver Park Subdivision, located in Government Lot 2, Section 28, Township 40 North, Range 10 East, being more particularly described as follows:

Commencing at the Southeast corner of Government Lot 2, Section 28, Township 40 North, Range 10 East, marked by a 6" x 6" concrete monument, as the Place of Beginning; thence North 89° 45' 08" West a distance of 243.27 feet to an iron pipe; thence North 33° 03' 34" East a distance of 109.14 feet to an iron pipe; thence North 2° 44' 53" East a distance of 87.33 feet to an iron pipe on the North line of Lot 72 of Oliver Park Subdivision; thence South 84° 35' 42" East a distance of 163.43 feet to an iron pipe; thence South 75° 24' 56" East a distance of 145.22 feet to an iron pipe near the shore of Yellow Birch Lake; thence South 47° 40' 34" West a distance of 63.25 feet to a point; thence South 42° 04' 53" West a distance of 114.80 feet (South 42° 07" West 115 feet) to the Place of Beginning of this description.

Including all lands lying between the side lot lines extended to Yellow Birch Lake.

SECTION 2. Effect of Annexation. From and after the date of this ordinance the territory described in section 1 shall be a part of the City of Eagle River for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Eagle River.

SECTION 3.**Zoning Classification.** (a) Upon recommendation of the Plan Commission, the territory annexed to the City of Eagle River by this ordinance is zoned as follows, pursuant to sec. 66.0217 of the Wisconsin Statutes:

Single & Two Family Residence

SECTION 4. Ward Designation. The territory described in section 1 of this ordinance is hereby made a part of ward 5 of the City of Eagle River.

SECTION 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.


SECTION 6. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.



Including all lands lying between the side lot lines extended to Yellow Birch Lake.
