PURSUANT TO SEC. 66.021, WISCONSIN STATUES



AN ORDINANCE ANNEXING TERRITORY TO THE VILLAGE OF CASCO, WISCONSIN

The Village board of the Village of Casco, Wisconsin, do ordain as follows:

The east half of the southwest quarter of the southeast quarter Section seven Township Twenty-four North range twenty-four East, Town of Casco, Kewaunee county, Wisconsin.

AND

Part of the Northeast Quarter of the Northwest Quarter of the Northeast Quarter Section Eighteen Township Twenty-four North, Range Twenty-Four East Town of Casco, Kewaunee County, Wisconsin, described as follows;

Commencing at the Northeast corner of said section: thence south 88 48'02" West a distance of 1324.78 feet to an existing concrete monument marking the Northeast corner of said Northeast Quarter of the Northwest Quarter of the Northeast Quarter of Section Eighteen and point being the point of beginning; thence South 03 26'46" East a distance of 651.41 feet to the North line of S.T.H. 54 thence South 87 53'06" West along the North line a distance of 670.06 feet; thence North 01 46'13" West to distance of 662.19 feet to the North line of said Northeast Quarter Section; thence North 88 48'02" East a distance of 662.39 feet to the point of beginning.

SECTION 2. Effect of annexation. From and after the date of this ordinance the territory described in section 1 shall be a part of the Village of Casco for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Casco.

SECTION 3. The Zoning Classification. The territory annexed to the Village of Casco by this ordinance is zoned

Residential back portion Business 1st block off Hwy 54

SECTION 4. Severability: If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provision or applications of this ordinance, which can be given effect without the invalid or unconstitutional provision, or application.

SECTION 5. Effective date. This ordinance shall take effect upon passage and publication as provided by law.
