



## ORDINANCE ANNEXING LAND TO THE VILLAGE OF FRANCIS CREEK



AN ORDINANCE to annex certain territory from the Town of Kossuth to the Village of Francis Creek;

WHEREAS, the petition to annex the territory described on the attached Exhibit A has been filed with the Village of Francis Creek; and

WHEREAS, the petition meets the requirements of Wisconsin Statute §66.021(12); and

WHEREAS, the Village Board for the Village of Francis Creek has determined that the Village has a reasonable need for the property and it is in the best interest of the petitioners, the residents and owners of the property in the area to be annexed and the Village of Francis Creek to annex the property to the Village; and

WHEREAS, the Village has reviewed the recommendations of the Wisconsin Department of Development pursuant to Wisconsin Statute §66.021(11); and

WHEREAS, the petition meets the requirements of Wisconsin Statute §66.021(2)(a)(1).

NOW THEREFORE, the Village of Francis Creek hereby ordains as follows: That the land described in the attached Exhibit A be hereby annexed to the Village of Francis Creek.



#### Zone District Classification

The territory annexed is hereby classified as B-1 (Business) all according to the attached map (Exhibit B).

Passage of this ordinance has been approved by a twothirds (%) vote of the elected members of the Village Board.

This ordinance shall take effect on the day after the ordinance has been enacted.

#### HOLSCHBACH ANNEXATION TO THE VILLAGE OF FRANCIS CREEK

A tract of land in the SE  $^{1}/_{4}$  of the NW  $^{1}/_{4}$  and in the NE  $^{1}/_{4}$  of the NW  $^{1}/_{4}$  of Section 15. T.20N., R.23E., Town of Kossuth, Manitowoc County, Wisconsin and described as follows:

Commencing at the North <sup>1</sup>/<sub>4</sub> corner of said Section 15, thence S 01° 51'39" E along the <sup>1</sup>/<sub>4</sub> section line 1,286.62 feet to the north right of way of Apple Blossom Lane, the point of real beginning, thence continue S 01° 51'39" E along said <sup>1</sup>/<sub>4</sub> section line 314.59 feet, to the south line of a certified survey recorded in Volume 14, Page 337, thence S 88° 08'34" W along said south line 377.26 feet to the west line of said certified survey, thence N 01° 51'39" W along said west line 314.59 feet to said north right of way, thence N 88° 08'34" E along said right of way 377.26 feet to the point of real beginning.

Said tract contains 2.72 acres.
