BOUNDARY DESCRIPTION VILLAGE OF GAYS MILLS - CRAWFORD COUNTY CORPORATE LIMITS

Commencing at the northeast corner of Section 22, Township 10 North, Range 4 West, said corner being the point of beginning, thence South along the east line of said Section 22 to the southeast corner of said Section 22, thence West along the south line of said Section 22 to the southwest corner of the Southeast ¼ of the Southeast ¼ of said Section 22, thence South to the southeast corner of the Southwest ¼ of the Northeast ¼ of Section 27, Township 10 North, Range 4 West, thence West to the southwest corner of the Southwest ¼ of the Northeast ¼ of said Section 27, thence South to the southeast corner of the Southeast ¼ of the Southwest ¼ of said Section 27, thence West to the southwest corner of said Section 27, thence continuing west along the south line of Section 28, Township 10 North, Range 4 West, to the southwest corner of the Southwest ¼ of the Southeast ¼ of said Section 28, thence South to the southeast corner of the Northeast ¼ of the Northwest ¼ of Section 33, Township 10 North, Range 4 West, thence West to the southwest corner of the Northwest ¼ of the Northwest ¼ of said Section 33, thence continuing West through Section 32, Township 10 North, Range 4 West, to the southwest corner of the Northwest ¼ of the Northeast ¼ of said Section 32, thence North to the northwest corner of the Northwest ¼ of the Northeast ¼ of said Section 32, thence continuing North through Section 29, Township 10 North, Range 4 West, to the northwest corner of the Northwest ¼ of the Northeast ¼ of said Section 29, thence East to the northeast corner of the Northwest ¼ of the Northeast ¼ of said Section 29, thence North through Section 20, Township 10 North, Range 4 West, to the northwest corner of the Northeast ¼ of the Northeast ¼ of said Section 20, thence East to the northeast corner of said Section 20, thence continuing East along the north line of Section 21, Township 10 North, Range 4 West, to the east bank of the Kickapoo River, thence northerly along the east bank of the Kickapoo River through the Southeast ¼ of the Southeast ¼ of Section 16, Township 10 North, Range 4 West, to the west line of the Southeast ¼ of the Southeast ¼ of said Section 16, thence North along the west line of the Southeast 1/4 of the Southeast ¼ of said Section 16 to the easterly bank of the Kickapoo River, thence northerly along the easterly bank of the Kickapoo River to the north line of the Southeast ¼ of the Southeast ¼ of said Section 16, thence northerly along the east bank of the Kickapoo River through the Northeast ¼ of the Southeast ¼ of said Section 16 to the west line of the

Northeast ¼ of the Southeast ¼ of said Section 16, thence North along the west line of the Northeast ¼ of the Southeast ¼ of said Section 16 to the easterly bank of the Kickapoo River, thence northerly along the east bank of the Kickapoo River through the Southeast ¼ of the Northeast ¼ of said Section 16 to the east line of the Southeast ¼ of the Northeast ¼ of said Section 16, thence South to the southeast corner of the Southeast ¼ of the Northeast ¼ of said Section 16, thence East along the north line of the Northwest ¼ of the Southwest ¼ of Section 15, Township 10 North, Range 4 West, to the west rightof-way of State Trunk Highway "131", thence south along said west right-of-way through the Northwest ¼ of the Southwest ¼ and the Southwest ¼ of the Southwest ¼ of said Section 15 to the north line of said Section 22, thence east along the north line of said Section 22 to the point of beginning.
