# CORPORATE LIMITS OF THE VILLAGE OF KENDALL LEGAL DESCRIPTION 12-01-2003

The East Half of the Southeast Quarter (E 1/2 SE ¼) and the Southeast Quarter of the Northeast Quarter (SE ¼ NE ¼) of Section Nine (9), Township Fifteen (15) North, Range One (1) East, Town of Glendale, Monroe County, Wisconsin.

The Southwest Quarter (SW ¼) and the West Half of the Southeast Quarter (W ½ SE ¼), and the South Half of the Northwest Quarter (S ½ NW ¼) and the Southwest Quarter of the Northeast Quarter (SW ¼ NE ¼) of Section Ten (10), Township Fifteen (15) North, Range One (1) East, Town of Glendale, Monroe County, Wisconsin.

Part of the Northwest Quarter of the Northwest Quarter (NW ¼ NW ¼) of Section Ten (10), Township Fifteen (15) North, Range One (1) East, Town of Glendale, Monroe County, Wisconsin, described as follows: Commencing at a point 42 rods East of the Southwest corner of the Northwest Quarter of the Northwest Quarter (NW ¼ NW ¼); thence East 12 rods; thence North 7 rods; thence West 12 rods; thence South 7 rods, to the place of beginning.

Part of the Northeast Quarter of the Southeast Quarter (NE ¼ SE ¼) of Section Ten (10), Township Fifteen (15) North, Range One (1) East, Town of Glendale, Monroe County, Wisconsin, described as follows: Beginning at the Northwest corner of said NE ¼ SE ¼; thence N 86 degrees 17' 16" E along the north line of said NE ¼ SE ¼, 300 feet; thence S 1 degree 53' 39" W, 422.85 feet to the centerline of C.T.H. "P"; thence N 75 degrees 34' 45" W along the centerline of said C.T.H. "P" 300 feet; thence N 0 degrees 53' 56" E along the West line of said NE ¼ SE ¼, 328.52 feet to the point of beginning. Said parcel contains 2.55 acres of land, more or less, reserving those lands used for County Road purposes.
