ORDINANCE NO. 952

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF LAKE MILLS, JEFFERSON COUNTY, WISCONSIN

THE COMMON COUNCIL OF THE CITY OF LAKE MILLS, JEFFERSON COUNTY, WISCONSIN, DOES ORDAIN AS FOLLOWS:

Section 1. Territory Annexed. In accordance with Section 66.0217 of the Wisconsin Statutes and the petition for direct annexation filed with the City Clerk on February 4, 2005, signed by the owners of the property proposed to be annexed, the following territory in the Town of Lake Mills, Jefferson County, Wisconsin, is annexed to the City of Lake Mills, Jefferson County, Wisconsin.

Being a part of the S ½ of the SE ¼ of Section 1, T.7N.,R.13E., Town of Lake Mills, Jefferson County, Wisconsin, more fully described as follows:

Beginning at the SE corner of said Section 1; thence S.88°19'33"W., along the south line of the SE ¼ of sand Section 1, 1,296.14 feet to a point 1,291.65 feet easterly of the S ¼ corner of said Section 1; thence N.06°08'20"E., 1,014.41 feet; thence N.03°22'25"E., 328.14 feet to the north line of the south ½ of said SE ¼ and a point 1,407.72 feet easterly of the west line of said SE ¼; thence N.88°29'23"E., along said north line, 1,179.01 feet to the east line of said SE ¼; thence S.00°27'57"W., along said east line, 1,329.42 feet to the point of beginning. Said lands contain 38 acres.

Section 2. Effect of Annexation. From and after the date of this ordinance, the territory described in Section 1 shall be part of the City of Lake Mills, Jefferson County, Wisconsin, for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Lake Mills.

<u>Section 3. Ward Designation</u>. The territory described in Section 1 of this ordinance is hereby made a part of the First Ward of the City of Lake Mills, subject to the ordinances, rules and regulations of the City of Lake Mills governing wards.

<u>Section 4. Severability</u>. If any provision of this ordinance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance that can be given effect without the invalid or unconstitutional provision of application.

<u>Section 5. Effective Date.</u> This ordinance shall take effect upon passage and publication as provided by law.




