

# AN ORDINANCE ANNEXING THE MATTHEW FINNEGAN AND RICHARD LAGRANT PROPERTY LOCATED AT 2135 SHOPIERE ROAD TO THE CITY OF BELOIT

The City Council of the City of Beloit, Rock County, Wisconsin, do ordain as follows:

Section 1. Territory Annexed. In accordance with Section 66.0217(2) of Wisconsin Statutes and the Petition for Direct Annexation filed by Matthew Finnegan and Richard LaGrant with the City Clerk on the 28<sup>th</sup> day of October, 2005, signed by all of the owners of real property of the following described property in the Town of Turtle, Rock County, Wisconsin, the following territory is annexed to the City of Beloit, Wisconsin:

Lots 8, 9 and 10 of Block 9 of Lindale Place and part of Shopiere Road, all being part of the South ½ of the Southwest ¼ of Section 19, Township 1 North, Range 13 East of the 4<sup>th</sup> P.M., Turtle Township, Rock County, Wisconsin, DESCRIBED AS FOLLOWS: Beginning at the Northwesterly corner of lot 8, aforesaid; thence Northeasterly 150 feet to the Northeasterly corner of said lot 10; thence Southeasterly along a line between lots 10 and 11 a distance of 155 feet to the centerline of Shopiere Road; thence Southwesterly along said centerline 150 feet; thence Northwesterly along the extension of the line between lots 7 and 8 a distance of 155 feet to the place of beginning. Containing 23,250 square feet.

Section 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1 shall be part of the City of Beloit for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules, and regulations governing the City of Beloit.

Section 3. Payment to Town of Turtle The City of Beloit agrees to pay the Town of Turtle, for five (5) years, an amount equal to the amount of property taxes levied on the annexed territory by the Town of Beloit in 2005 as shown on the Town of Turtle's tax roll prepared pursuant to Section 70.65 Wisconsin Statutes.

Section 4. Temporary Zoning Classification. A) The territory annexed to the City of Beloit by this ordinance is temporarily designated to be part of the following district of the City for zoning purposes and subject to all provisions of Chapter 19 of the Code of General Ordinances of the City of Beloit, entitled "The City of Beloit Zoning Ordinance" relating to such district classifications and to zoning in the City: R-1B, Single-family Residential District. B) The boundaries of these designated districts are established as shown on the map filed in the office of the City Clerk. C) The Plan Commission is directed to initiate an amendment to the zoning ordinance not later than 30 days from the effective date of this ordinance setting forth a permanent classification and regulations for the zoning of the annexed area and to submit its recommendations to the City Council.

Section 5. Ward Designation. The territories described in Section 1 of this ordinance are hereby made a part of the <u>Twenty-first (21<sup>st</sup>) Ward</u> of the City of Beloit, subject to the ordinances, rules, and regulations of the City, governing ward districts.

Section 6. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance, which can be given effect without the invalid or unconstitutional provision or application.

Section 7. Effective Date. This ordinance shall take effect and be in force upon its passage and publication.


