CORPORATE LIMITS OF THE CITY OF ST. CROIX FALLS December 1, 2004

Part of Sections 17, 18, 19, 20, 28, 29, 30, 31, 32, 33 and 34 of Township 34 North, Range 18 West in Polk County, Wisconsin, and more particularly described as follows, to-wit:

Commencing at the Northwest corner of Government Lot 1, Section 19, Township 34 North, Range 18 West; thence East 6 chains to the shore of the St. Croix River and the point of beginning; thence in a Northerly along the shore of said St. Croix River 1320 feet, more or less to the North line of Government 4 of said Section 18; thence Easterly along the Northerly of said Government Lot 4 to the Easterly right-of-way of S.T.H.
