CERTIFICATE FOR REPORTING CORPORATE LIMITS OF VILLAGE AFTER ALTERATION

I, Janice K. Winget, Village Clerk of the Village of Union Grove, County of Racine. State of Wisconsin, DO HEREBY CERTIFY that the Corporate Boundaries of the said Village have been altered within the 12 month period ending January 27, 2006 and that the following description is the present Corporate Limits of the said Village as of January 27, 2006.

DESCRIPTION OF CORPORATE LIMITS

Beginning at the Center 1/4 corner of Section 30, Town 3 North, Range 21 East, of the 4th Principal Meridian, run thence Southerly along the North-South 1/4 section line to a point that is 1058.22 feet Northerly of the South 1/4 corner of Section 30; thence due West 49.50 feet to a point in the centerline of 10th Avenue; thence Northwesterly in said centerline on a curve of southerly convexity whose radius is 806.30 feet and whose long chord bears North 78 degrees 05 minutes West 105.25 feet to a point; thence Northwesterly in said centerline on a curve of northerly convexity whose radius is 569.03 feet and whose long chord bears North 86 degrees 01 minutes West 178.25 feet, to a point; thence Southwesterly in said centerline on a curve of northerly convexity whose radius is 1516.80 feet and whose long chord bears South 81 degrees 58 minutes West 75.00 feet; thence Northerly, 1463.05 feet, more or less, to a point on the East-West 1/4 line which is 398.08 feet Westerly of said center 1/4 corner; thence North 89 degrees 49 minutes West 864.60 feet, along said East-West 1/4 line to a point; thence South 1347.05 feet, to a point; thence East 207.10 feet, more or less, to a point; thence South 226.10 feet to a point on the centerline of 10th Avenue; thence North 80 degrees 33 minutes 30 second East, 210.35 feet, more or less, to a point; thence due South 84.85 feet to the northerly right-of-way line of the Chicago, Milwaukee, St. Paul and Pacific Railroad; thence North 83 degrees 14 minutes East 800.00 feet, more or less, along said northerly right-of-way line, to a point on the West right-of-way line of York Street; thence Southeasterly 100 feet, more of along said West line to the Southerly right-of-way line of the Chicago, Milwaukee, St. Paul and Pacific Railroad; thence South 81 degrees 36 minutes 19 seconds West, 2487.50 feet, more or less; thence South 10 degrees 33 minutes 56 seconds East 320 feet, more or less; thence East along the south line of the Southwest 1/4 of Section 30, 493.02 feet; thence South 976.80 feet, more or less, to the center of State Trunk Highway No. 11; thence Easterly along the center of said highway 180/52 feet; thence north 0 degrees 05 minutes West 444.89 feet; thence North 89 degrees 54 minutes 30 seconded East 573.36 feet; thence north 0 degrees 05 minutes East 536.93 feet; thence East on the North line of the West ½ of the Northwest ¼ of Section 31.
