

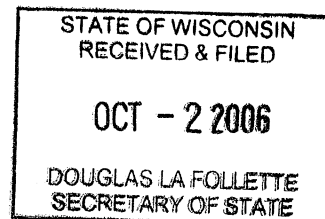

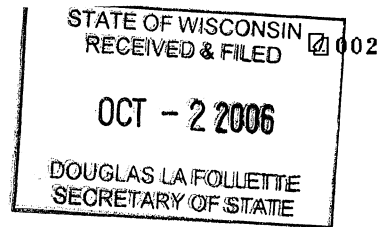

ORDINANCE S - 82

**AN ORDINANCE TO ANNEX TERRITORY IN
THE TOWN OF LODI, WISCONSIN TO THE CITY OF LODI, WISCONSIN**

The Common Council of the City of Lodi, Columbia County, Wisconsin, do ordain as follows:

Section 1. **Territory Annexed.** In accordance with Section 66.0223 the Wisconsin Statutes, the following territory in the Town of Lodi, Columbia County, Wisconsin, owned entirely by the City of Lodi, is annexed to the City of Lodi, Wisconsin;

Being a part of the Southeast Quarter of the Northeast Quarter of Section 28, Town 10 North, Range 8 East, Town of Lodi, Columbia County, Wisconsin, described as follows:

Beginning at the East Quarter Corner of said Section 28 which is the point of beginning; thence S89°05'22"W along the south line of said Southeast Quarter of the Northeast Quarter, 1321.78 feet; thence N00°07'41"E along the east line of said Southeast Quarter of the Northeast Quarter, 1124.23 feet; thence N89°09'31"E, 1324.83 feet to a point on the east line of said Southeast Quarter of the Northeast Quarter; thence S00°17'05"W along said east line, 1122.69 feet to the point of beginning.

Containing 1,486,413 square feet (34.12 acres) more or less.

Section 2. **Effective Annexation.** From and after the date of this Ordinance the territory described in Section 1 shall be a part of the City of Lodi, Columbia County, Wisconsin for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all Ordinances, Rules and Regulation governing the City of Lodi.

Section 3. **Severability.** If any provision of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstances invalid or unconstitutional, such invalidity or unconstitutionality shall not effect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provisions or application.

Section 4. **Effective Date.** This Ordinance shall take place upon the effective passage and publication as provided by law.

Adopted by the Common Council of the City of Lodi, Wisconsin on this 2nd day of May, 2006 on a roll call vote of 4 ayes and 0 nays.

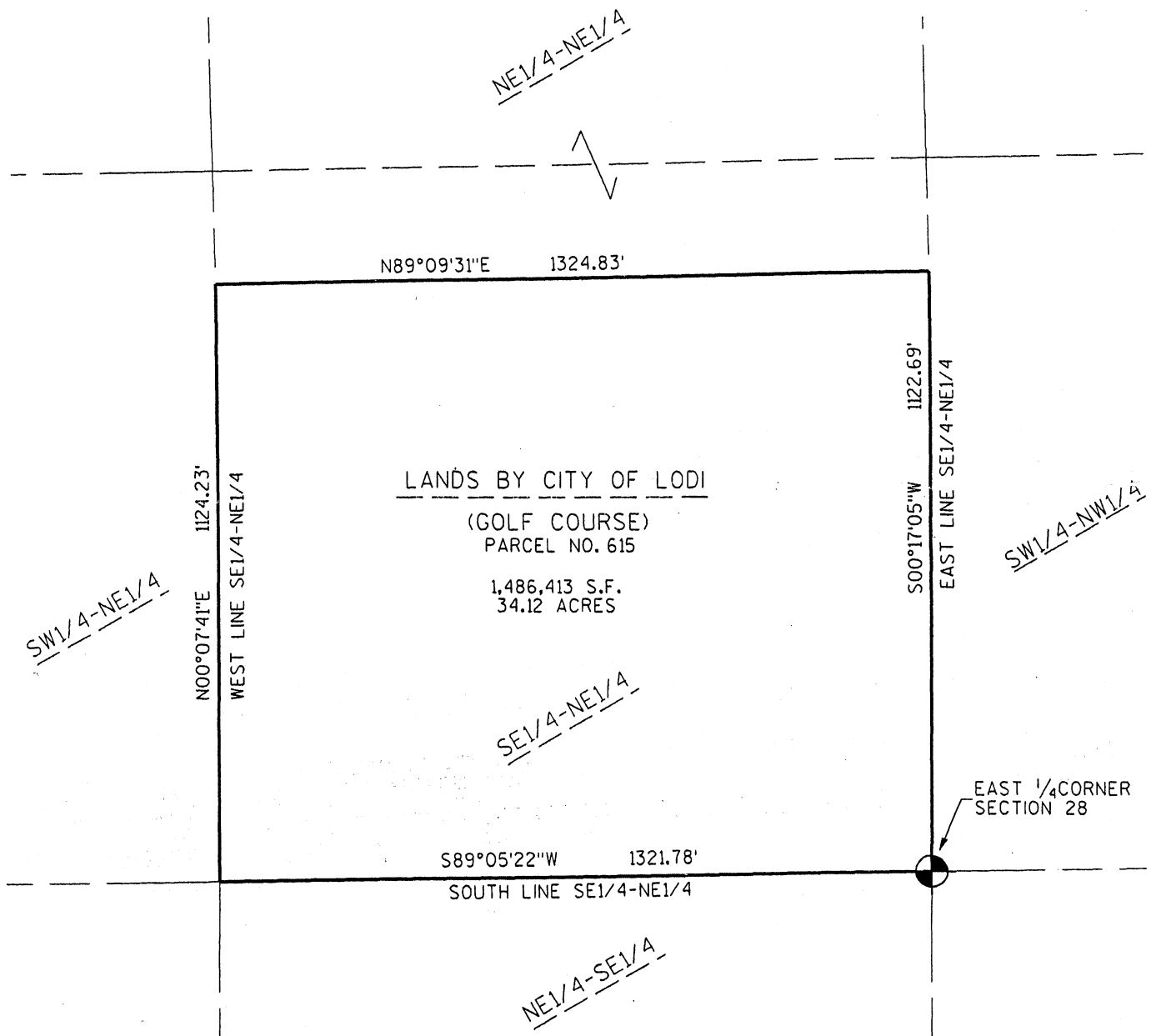

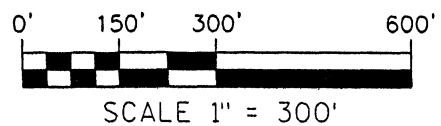
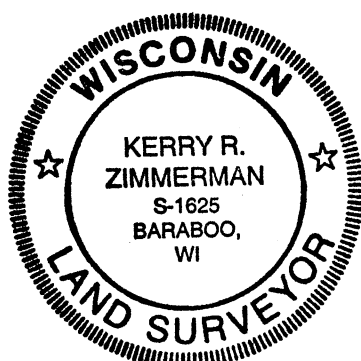
