ORDINANCE NO. 06-720

AN ORDINANCE ANNEXING THE HEREIN DESCRIBED PROPERTY TO THE CITY OF VERONA, DANE COUNTY, WISCONSIN

The Common Council of the City of Verona, Dane County, State of Wisconsin, by at least a two-thirds (2/3) vote of its members, does hereby ordain as follows:

Section 1. <u>Territory Annexed</u>.

In accordance with Section 66.0217(2) of the Wisconsin Statutes and the Petition for Annexation filed with the City Clerk on June 5, 2006, signed by all of the owners of the real property in assessed value in the territory, there being three (3) owners and no people residing in said territory, the following described territory in the Town of Verona, Dane County, Wisconsin, attached as Exhibit A.

Section 2. Effect of Annexation.

From and after the date of this Ordinance, the territory described in Section 1 shall be a part of the City of Verona, Dane County, Wisconsin for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Verona.

Section 3. Temporary Zoning Classification.

Upon recommendation by the Plan Commission, the territory annexed to the City of Verona by this Ordinance is designated to be a part of the following district of the City for zoning purposes and subject to all provisions of the zoning ordinance of the City of Verona relating to such district classification and to zoning in the City: Rural Agriculture (RA).

Section 4. Voting Districts.

The territory annexed shall be within the following voting district:

Aldermanic District No. 1 Ward No. 2 Dane County Supervisory District No. 32

Section 5. Severability.

If any provision of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.

Section 6. Tax Payments to the Town of Verona.

The City of Verona agrees to pay annually to the town of Verona, for 5 years, an amount equal to the amount of property taxes that the town levied on the annexed territory, as shown on the tax roll under Section 70.65 of the Wisconsin Statutes, in the year in which the annexation is final.

Section 7. Effective Date.

This Ordinance shall be effective upon enactment as provided by Section 66.0217(6) and (8)(c) of the Wisconsin Statutes.

Being part of the Northeast Quarter of the Northwest Quarter (NE ¼ - NW ¼), Section 21, part of the Southeast Quarter of the Southeast Quarter (SE ¼ - SE ¼), part of the Southwest Quarter of the Southeast Quarter (SW ¼ - SE ¼) and part of the Southeast Quarter of the Southwest Quarter (SE ¼ - SW ¼), Section 16, all in Township 06 North, Range 08 East, Town of Verona, Dane County, Wisconsin, described as follows:

Commencing at the Southwest corner of said Section 16;

Thence easterly, along the south line of said Southwest Quarter (SW ¼) to the West line of the Southeast Quarter of the Southwest Quarter (SE ¼ - SW ¼) of said Section 16:

Thence northerly, along the West line of the Southeast Quarter of the Southwest Quarter (SE ¼ - SW ¼) to the Northerly right of way line of West Verona Avenue (former USH 18/151) and the point of beginning;

Thence southerly along the West line of the Southeast Quarter of the Southwest Quarter (SE ¼ - SW ¼) of said Section 16 and the West line of the Northeast Quarter of the Northwest Quarter (NE ¼ -NW ¼) of said Section 21, 135 feet, more or less, to the "W1" Reference Line as described in Wisconsin Department of Transportation Right of Way Plat, R/W Project Number 1201-04-21;

Thence northeasterly along said "W1" Reference Line and the arc of a 1,909.87 foot radius curve to the right, to a point of tangency at station 533+25.76 "W1";


