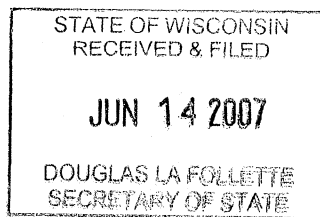

Charter Ord. No. 4 - 07 - 08. By Alderpersons Montemayor and Verhasselt.  
May 7, 2007.

A CHARTER ORDINANCE providing for the appointment of the City Engineer  
by the Director of Planning and Development.

THE COMMON COUNCIL OF THE CITY OF SHEBOYGAN DO ORDAIN AS FOLLOWS:

Section 1. Section 2-306 of the City of Sheboygan Municipal Code is  
hereby repealed and recreated to read as follows:

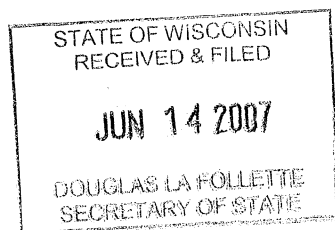
"Sec. 2-306. Appointment.

The city engineer shall be appointed by the director of  
planning and development, subject to confirmation of the common  
council."

Section 2. All ordinances or parts of ordinances contravening the  
provisions of this ordinance are hereby repealed.

Section 3. This is a charter ordinance and shall take effect sixty (60)  
days after its passage and publication, unless within such sixty (60) days  
after its passage and publication a referendum petition shall be filed as  
provided in section 66.0101 of the Wisconsin Statutes, in which event this  
ordinance shall not take effect until it shall have been submitted to a  
referendum of the electors and approved by a majority of the electors voting  
thereon.
