**AN ORDINANCE ANNEXING TERRITORY TO THE
VILLAGE OF HAMMOND, WISCONSIN**

The village board of the village of Hammond, Wisconsin, do ordain as follows:

SECTION 1. Territory annexed. (Direct Annexation by Unanimous Approval)


In accordance with sec. 66.021 of the Wisconsin Statutes and the petition for direct annexation by unanimous approval filed with the Village Clerk on July 14, 1997, signed by St. Croix Electric Cooperative, the owner of the territory to be annexed, the following described territory in the town of Hammond, St. Croix County, Wisconsin, is annexed to the village of Hammond, St. Croix County, Wisconsin, as described and mapped on Exhibits A and B attached hereto and made a part hereof.


SECTION 2. Effect of Annexation.

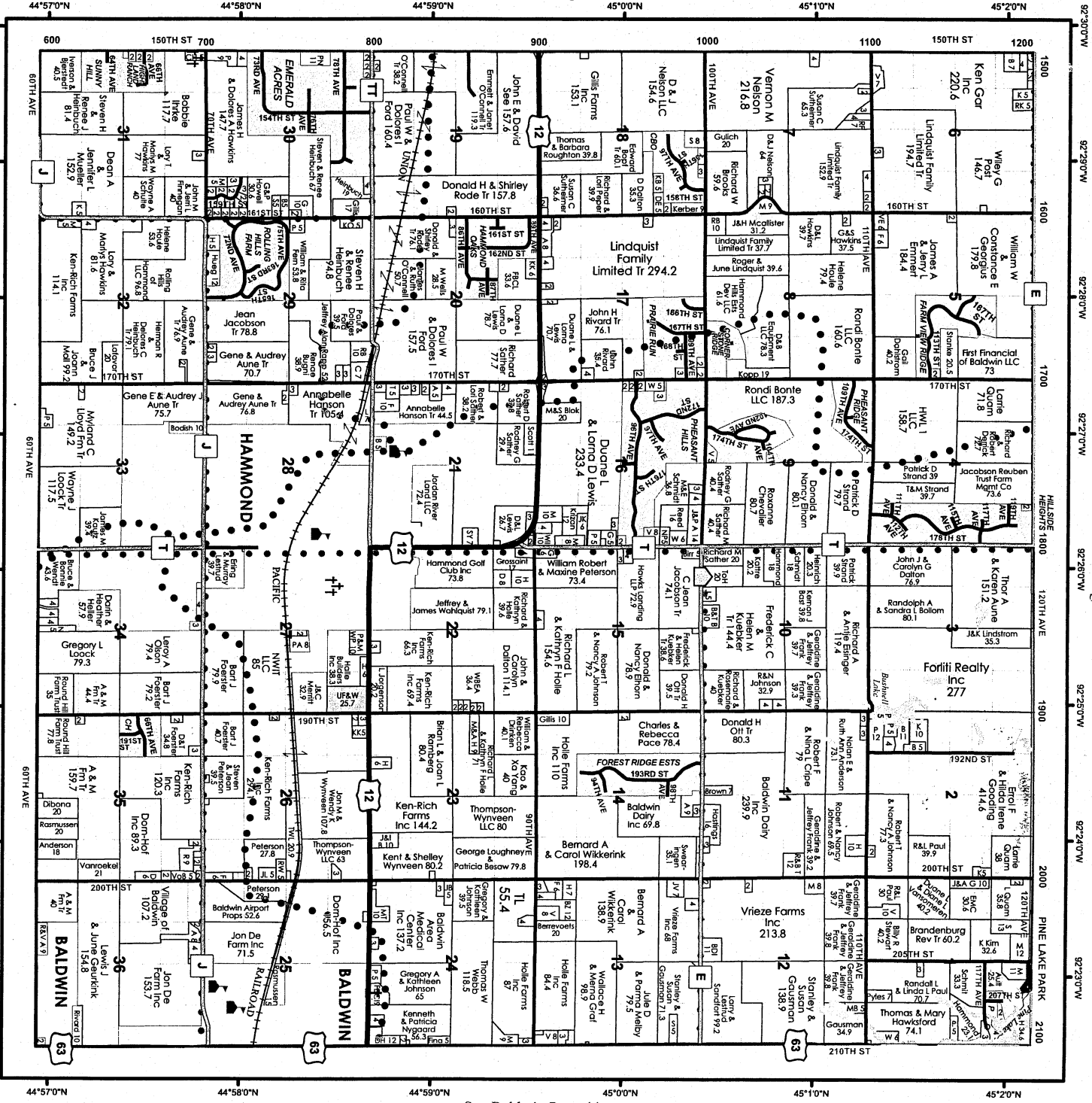
