I, Cheryl Menon, Clerk-Treasurer of the City of Dodgeville, Iowa County, State of Wisconsin, Do HEREBY CERTIFY THAT the corporate boundaries of the City have been altered within the previous 12 month period ending December 31, 2007 and that the following description is the present limits of the said City as of December 31, 2007.
