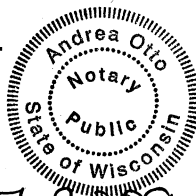

**THE VILLAGE BOARD OF THE VILLAGE OF SOMERSET, WISCONSIN DO  
ORDAIN AS FOLLOWS:**

**SECTION 1. TERRITORY ANNEXED.** In accordance with Section 66.0217 of the Wisconsin Statutes and the petition for direct annexation filed with the Village Clerk on the 20<sup>th</sup> day of January 2009, signed by all of the owners and electors, the following described territory in the Town of Somerset, St. Croix County, Wisconsin, is annexed to the Village of Somerset, Wisconsin:

**Parcel Description:** The Southeast Quarter of the Northeast Quarter (SE 1/4 of NE 1/4) of Section four (4), Township thirty (30) North, Range nineteen (19) West, being approximately forty (40) acres, all in the Town of Somerset, St. Croix County, Wisconsin.

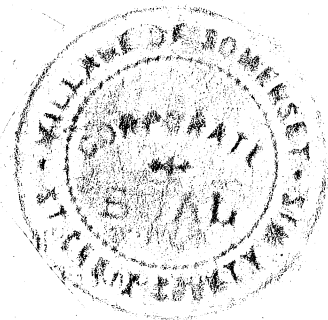


**SECTION 3. ZONING CLASSIFICATION.** The territory annexed hereby to the Village of Somerset is zoned Agricultural and subject to all provisions of the zoning ordinance of the village of Somerset.

**SECTION 4. SEVERABILITY.** If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provisions or application.

**SECTION 5. POPULATION.** The current population of the area is zero (0).

**SECTION 6. EFFECTIVE DATE.** This ordinance shall take effect upon passage and publication as provided by law.



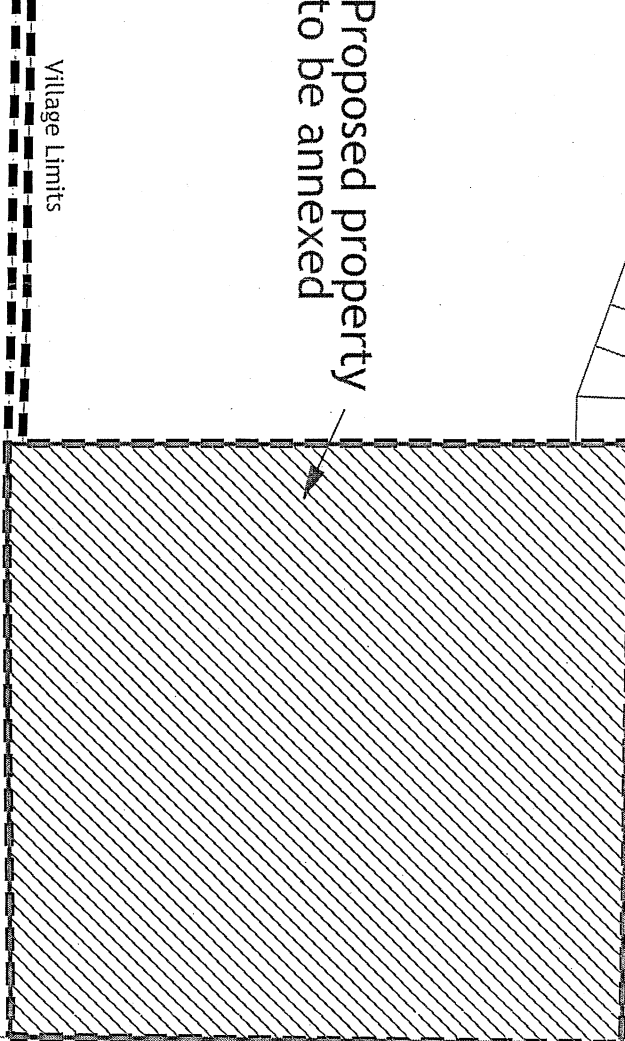
# PROPOSED ANNEXATION

Village Limits



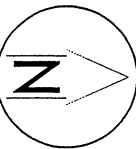
