

**THE COMMON COUNCIL OF THE CITY OF GILLETT, WISCONSIN, DO ORDAIN**  
that the Municipal Code of the City of Gillett is hereby amended to annex the following property as follows:

1. AUTHORITY. Pursuant to Section 66.0223, Stats., the Common Council may annex territory owned by and lying near but not necessarily contiguous to the City by Ordinance adopted by the Common Council of said City.

2. TERRITORY ANNEXED. The City of Gillett Common Council hereby annexes *A strip of land 100 feet in width extending over and across; the Southwest Quarter of the Northeast Quarter, and the Southeast Quarter, of Section 22; the Southwest Quarter of Section 23; the Northwest Quarter, and the Southwest Quarter of the Northeast Quarter, of Section 26, all in Township 28 North, Range 18 East of the Fourth Principal Meridian, said strip of land being 50 feet in width on each side of the center line of the main track (now removed) of the Manitowoc, Green Bay and North Western Railway Company (now the Chicago and North Western Transportation Company), as said main track center line was originally located and established over and across said Sections 22, 23, and 26.*

Also:

*A strip of land 100 feet in width extending over and across part of the Northwest Quarter of the Southeast Quarter of said Section 26, said strip of land being 50 feet in width on each side of said original main track center line, and lying Northerly of a line drawn radially to said center line at a point thereon distant 902 feet Southerly from the intersection thereof with the North line of the Southeast Quarter of said Section 26.*

The above described property is hereby annexed to the City of Gillett, Oconto County, Wisconsin.

3. ZONING CLASSIFICATION. The property shall be temporarily zoned FD Future Development District until permanent zoning can be established. The Planning Committee is hereby authorized and directed to recommend to the Council an amendment to the Gillett Zoning Map setting forth a permanent classification and regulations for the annexed area, after the Committee considers the most appropriate use consistent with the adopted Comprehensive Plan. Such recommendation for permanent zoning district classification shall be submitted to the Common Council within ninety (90) days after passage of the Annexation Ordinance.

4. WARD DESIGNATION. The territory described in this ordinance is hereby made a part of the 1, 4 Ward, 1st Aldermanic District of the City of Gillett.


5. DETACHMENT. The area which is hereby annexed is presently located in the Town of Gillett, Wisconsin and said territory shall be detached from said Town and shall be attached to the City of Gillett upon the City Clerk-Treasurer complying with Section 66.0223, Stats.

6. COMPLIANCE WITH SECTION 66.0217(14), STATS. The City has or agrees to pay the township from which the described property is being detached, the payment required under Section 66.0217(14), Stats.

7. EFFECT OF ANNEXATION. From and after the date of this ordinance, and upon the City Clerk filing seven (7) certified copies of this ordinance in the office of the Secretary of State, together with seven (7) copies of a plat showing the boundaries of the territory attached, the territory described herein shall be a part of the City of Gillett, Wisconsin, for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Gillett.

This Ordinance shall take effect upon passage and publication provided by law.

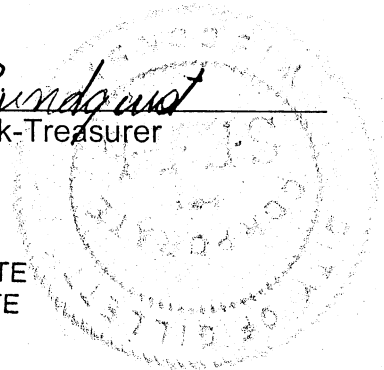

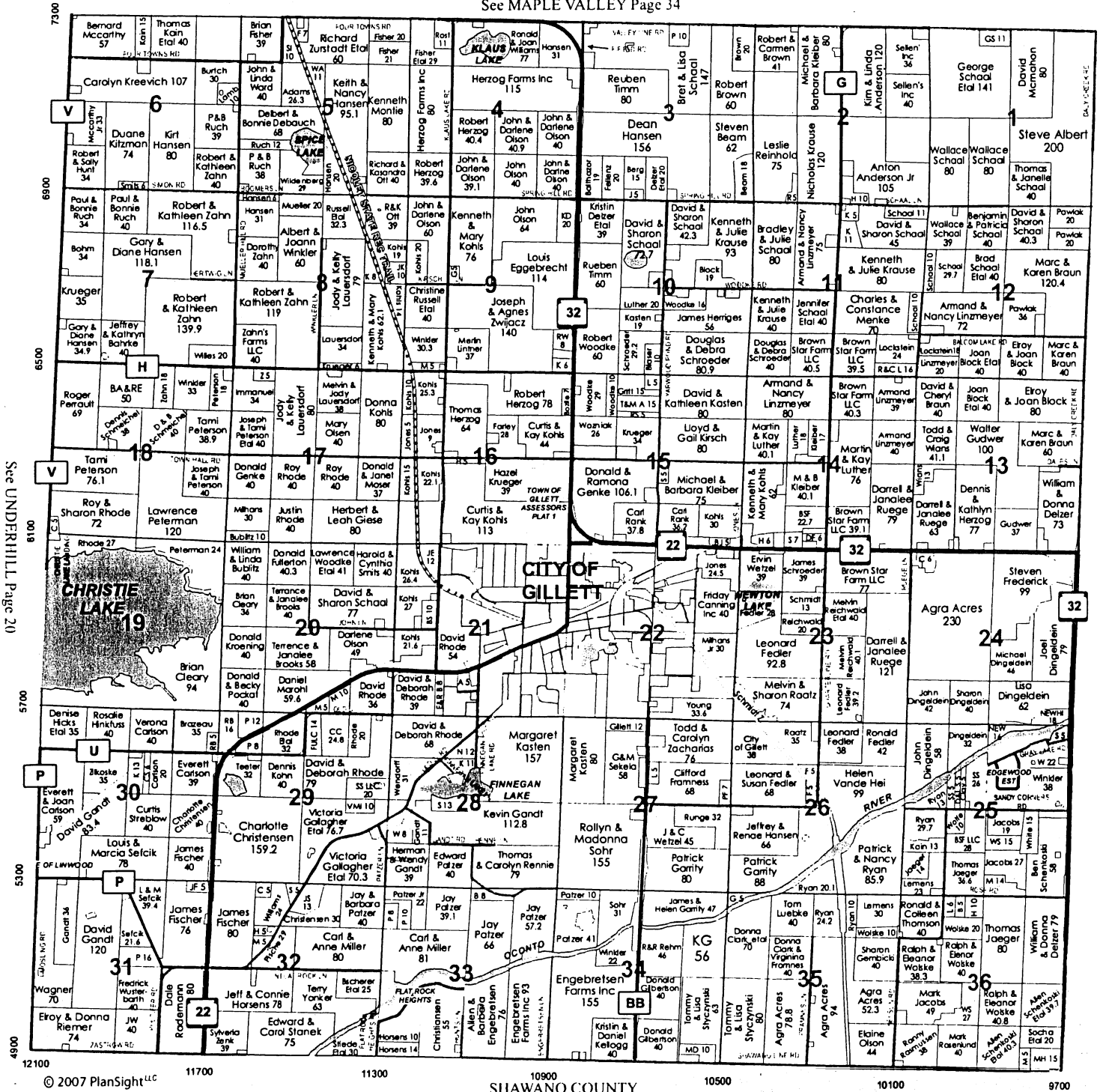

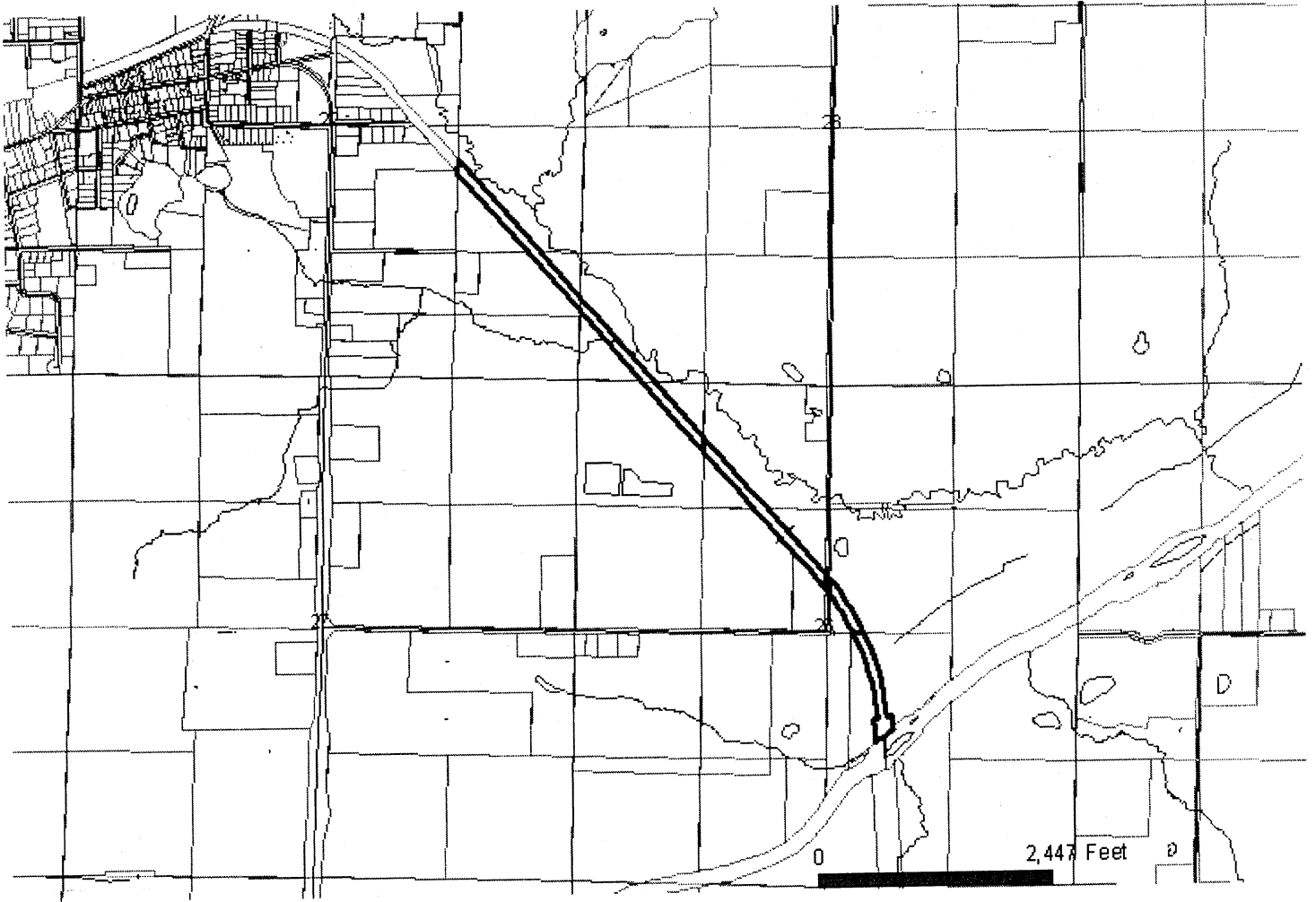
