ORDINANCE NO. 06-10

AN ORDINANCE ANNEXING LAND OWNED BY THE CITY OF PEWAUKEE

WHEREAS, the City of Pewaukee has purchased land in the Town of Brookfield for the purpose of building a fire station; and,

WHEREAS, the City wishes to annex that property into the City in order to proceed with the proper zoning and planning necessary to enable it to construct a fire station.

NOW THEREFORE, the Common Council of the City of Pewaukee hereby enacts the following ordinance:

SECTION 1:

Pursuant to §66.0223, Wis. Stats., the City of Pewaukee annexes from the Town of Brookfield, the parcel commonly known as the Gumina parcel more fully described as: Lot 2 of CSM 10,132 recorded on December 15, 2005, Volume 95 of Certified Survey Maps on pages 191 to 194 as Document No. 3346475 being a division of part of the Northwest 1/4 and the Southwest 1/4 of the Northwest 1/4 of section 7, Town 7 North, Range 21 East, in the Town of Brookfield, County of Waukesha, State of Wisconsin.

SECTION 2:

This annexation ordinance is accompanied by a plat of the parcel attached hereto as Exhibit A. Seven certified copies of this ordinance and the plat must be sent to the Wisconsin Secretary of State and one copy each to the Waukesha County Clerk and the Town of Brookfield Clerk.

SECTION 3: Severability.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinance whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 4: Effective Date.

This ordinance shall be effective upon the filing of the required copies with the Secretary of State, pursuant to §66.0223, Wis. Stats.



THAT I have surveyed, divided and mapped a division of part of the Northwest 1/4 and the Southwest 1/4 of the Northwest 1/4 of Section 7, Town 7 North, Range 20 East, Town of Brookfield, Waukesha County, Wisconsin, bounded and described as follows:

BEGINNING at the Northwest corner of the Northwest 1/4 of Section 7; thence North 85°32'05" East along the North line of said Northwest 1/4 Section 479.50 feet to a point; thence South 06°00'34" East 2236.31 feet to a point on the North line of Gumina Road; thence South 60°31'25" West along said North line 159.81 feet to a point; thence Southwesterly 347.14 feet along said North line and the arc of a curve whose center lies to the North, whose radius is 651.20 feet and whose chord bears South 75°47'42" West 343.04 feet to a point; thence North 88°56'00" West along said North line 189.96 feet to a point on the West line of said Northwest 1/4 Section; thence North 01°14'05" West along said West line 2346.51 feet the point of beginning.
