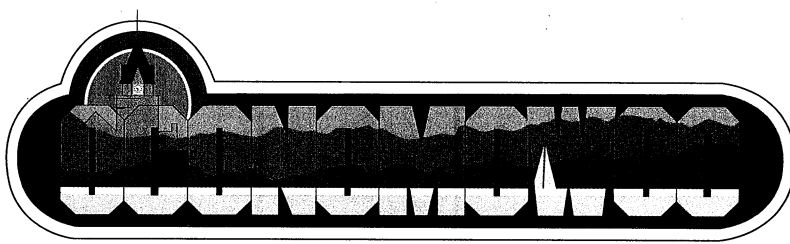

On December 31, 2009, 152 parcels will be attached to the City of Oconomowoc as part of the Boundary Agreement entered into between the Town of Summit and City of Oconomowoc.

In anticipation of the attachment and to help you prepare for January 1, 2010, the City is providing you with a list of those parcels and an estimated population of 300. This number was calculated based on the number of households coming into the City, 106 times the identified Census population of 2.86 individuals per household and also based on the 309 registered voters in the Town of Summit that will transfer to the City.
