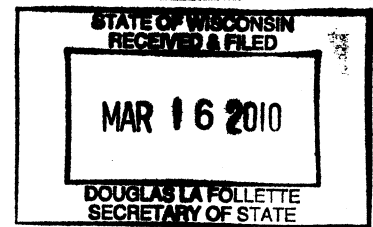

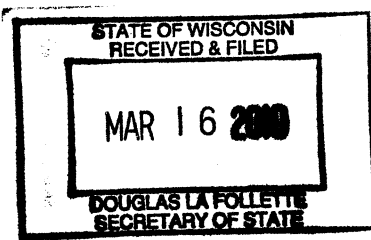

ORDINANCE NO. 2010-003

AN ORDINANCE ANNEXING TERRITORY LOCATED ADJACENT TO THE VILLAGE OF CLYMAN, WISCONSIN

The Village Board of the Village of Clyman, Wisconsin, do ordain as follows:

SECTION 1. Territory annexed. The Board of the Village of Clyman does hereby annex to the Village of Clyman, pursuant to the Village Board's power to annex property it owns under Wis. Stat. § 66.0223, the following described territory in the Village of Clyman, Dodge County, Wisconsin.

A tract of land located in the Southwest ¼ of the Southwest ¼ of Section 22, Town 10 North, Range 15 East, Town of Clyman, Dodge County, Wisconsin.

Commencing at the Southwest Corner of said Section 22; thence South 89°18'24" East, 1,322.36 feet along the South line of the Southwest ¼ to the Southeast corner of the Southwest ¼ of said Southwest ¼; thence North 01°07'26" East, 634.44 feet along the east line of the Southwest ¼ of said Southwest ¼ to the Northerly right-of-way line of C.T.H. "J"; and the POINT OF BEGINNING, thence along the Northerly right-of-way line the following courses:

1. North 89°33'23" West, 47.49 feet;
2. South 81°16'15" West, 152.07 feet;
3. North 89°16'01" West, 193.79 feet; thence North 06°49'43" East, 550.33 feet; thence South 89°18'24" East, 336.20 feet to the East line of the Southwest ¼ of said Southwest ¼; thence South 01°07'26" West, 527.19 feet along the said East line to the POINT OF BEGINNING.

Said parcel contains 196,040 square feet or 4.5 acres.

SECTION 2. Effect of Annexation. From and after the date of this ordinance, the territory described in Section 1 shall be a part of the Village of Clyman for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the Village of Clyman.

SECTION 3. Zoning Classification. Upon recommendation of the Village of Clyman Board, the territory annexed to the Village of Clyman by this ordinance is zoned as follows:

P-1, Public and Semi-Public District

SECTION 4. Designation. The territory described in Section 1 of this ordinance is hereby made part of the Village of Clyman, subject to the ordinances, rules and regulations of the Village of Clyman. The population of the property is zero.

SECTION 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications or this


ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 6. It is further ordained that the Clerk shall cause this Ordinance to be published as a Class 1 Notice. The Clerk shall also perform the filing requirements of Wis. Stat. § 66.0223(1).

SECTION 7. Effective Date. This ordinance shall take effect upon passage and posting as provided by law.



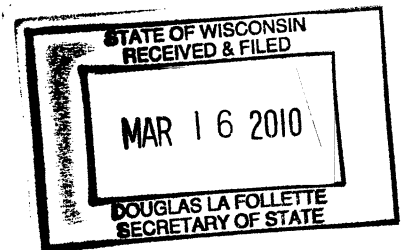


