

Re: The Incorporation of the Town of Summit as the Village of Summit, Waukesha County Circuit Court Case No. 08-CV-3145

Dear Judge Foster:

The Incorporation Review Board has reviewed the Summit incorporation petition to determine whether it meets the standards in s. 66.0207 Wis. Stats. You had forwarded the petition to the Board on November 7, 2008 after having found that the petition met the minimum area and population standards in s. 66.0205 Wis. Stats. According to s. 66.0203(9)(e) Wis. Stats., the Board has three options upon reviewing the petition against the statutory standards. The Board may find that:

- 1) The petition as submitted is dismissed;
- 2) The petition as submitted is granted.
- 3) The petition as submitted is dismissed with a recommendation that a new petition be submitted to include more or less territory as specified in the Board's findings and determination.

Based on testimony at a public hearing and on materials presented, the Board finds that the petition as submitted does meet the required standards in s. 66.0207 Wis. Stats. Therefore, the Board approves the petition for incorporation and recommends that you, as the circuit court judge presiding over this matter, order an incorporation referendum be held pursuant to ss. 66.0207(9)(f) and 66.0211 Wis.Stats.

I have included with this letter a copy of the Board's Findings and Determination document which concludes our work with this petition. The Incorporation Review Board and the Department of Administration will retain all supporting documents and records pursuant to Record Disposal Authorization for 10 years, after which they are transferred to the State Historical Society. Please advise if the court desires to inspect this record, or to have it copied in full for the court or the parties.

The Board very much appreciates the assistance provided by petitioners, elected officials, staff and consultants for the Town of Summit. Should you have any questions concerning this Determination, or wish to discuss other matters, please call me at (608) 267-1824.



Case No. 08 CV 3145

This firm represents the Town of Summit in Waukesha County. The Town is in the process of incorporating and has obtained the approval of the Incorporation Board (a copy is enclosed) and recently the approval of the electorate. Your office will soon receive a certification of the referendum results from the Waukesha County Clerk of Courts. Once that is received the certificate of incorporation is to be issued pursuant to §66.0211(5), Stats.

On behalf of the Town we ask that the certificate not be issued until July 29th. The reason for this request is that once the certificate is issued, the new village has to hold its first election for officers no less than 40 days, but no more than 50 days, from the date of the certificate. In order to hold down expenses, the Town wishes to hold the first election on the same day as the September primary which is September 14th. This request is similar to the one made by the Town/Village of Richfield back in 2008 which you were gracious enough to accommodate. It is also our understanding that a few of the Town officials would like to attend the issuing of the certificate, as those from Richfield did.

My office will be contacting you early next week to discuss our request. Should you have any other questions please do not hesitate to contact us. Thank you for your attention to this matter.







Current Town of Summit Boundary -2008 (16313.79 acres)







OF THE OF INCORPORATION of the VILLAGE OF SUMMIT WAUKESHA COUNTY, WISCONSIN

I, DOUGLAS LA FOLLETTE, Secretary of State of Wisconsin, Keeper of the Great Seal thereof and Custodian of the records relating to incorporations of towns, villages and cities, DO HEREBY CERTIFY THAT:

WHEREAS, on the 22nd day of July, 2010, documents pertaining to the incorporation of the Town of Summit as a village under the provisions of §66.0211(5), Wisconsin Statutes, were submitted to the Office of the Secretary of State of Wisconsin by the Clerk of Circuit Court of Waukesha County, Kathleen Madden, and;

WHEREAS, the Clerk of Circuit Court of Waukesha County has certified:

That pursuant to the return of votes cast at the election held on the 15th day of June, 2010, on the question of whether the Town of Summit should be incorporated as a village, a majority of the votes were cast in favor of a village as follows:

FOR the village: 483

AGAINST the village: 85

That the territory for incorporation of the Village of Summit has a population of 5181, according to the January 1, 2009 estimate of the Department of Administration of the State of Wisconsin, and;

That the description of land to be included within the village limits of Summit is legally described being all of Sections 13, 16-21, 23-33, 35, 36 and those parts of Sections 1, 4-9, 11, 12, 14, 15, 22 and 34 that are not part of the City of Oconomowoc, Village of Dousman, Village of Oconomowoc Lake or City of Delafield, all lands being in Township 07 North, Range 17 East, Township of Summit, Waukesha County, Wisconsin.

NOW, THEREFORE, I, DOUGLAS LA FOLLETTE, Secretary of State of Wisconsin, pursuant to Wisconsin Statutes 66.0211(5), do hereby declare that the area described above, situated in the Town of Summit, County of Waukesha, State of Wisconsin, is duly incorporated as a village and that from henceforth the said village shall be known as the:

VILLAGE OF SUMMIT

and be governed by the provisions of Chapter 66 of the Wisconsin Statutes and Laws amendatory thereof and supplementary thereto.

IN TESTIMONY WHEREOF, I have hereunto set my hand and affixed the Great Seal of the State of Wisconsin, in the City of Madison, this 29th day of July, 2010.
