

CHARTER ORDINANCE NO. 6 - 2013 AMENDING CHARTER ORDINANCE NO. 1-2010, SECTION 2, SUBSECTION 1.08(D)(2)(a) REGARDING COMPOSITION OF THE POLICE COMMISSION

Whereas, on June 15, 2010, a referendum was held in which a majority of electors in the Town of Summit, located in Waukesha County, Wisconsin, voted in favor of the town incorporating as a Village; and,

Whereas, on July 29, 2010, the Wisconsin Secretary of State issued a Certificate of Incorporation legally establishing and recognizing Summit's status as the Village of Summit; and

Whereas, on July 29, 2010, the interim Village Board met to review and adopt the initial governing structure of the Village of Summit, and organized this government in Charter Ordinance 1-2010, adopted under Wisconsin Statutes Section 66.0101(2); and

Whereas, Section 1.08(D)(2) of Charter Ordinance 1-2010 established the Village of Summit Police Commission; and

Whereas, Section 1.08(D)(2)(a) of Charter Ordinance 1-2010 requires that all of the members of the Summit Police Commission shall be residents of the Village who do not hold any other elected or appointed office in the Village; and

Whereas, on November 3, 2011, the Village of Summit Village Board approved a contract to provide police services to the Village of Dousman; and

Whereas, on August 8, 2013, the Village of Summit Village Board identified the potential for residents of the Village of Dousman to serve on the Police Commission, if appointed by the Village of Summit Village Board.

Now, therefore, pursuant to Section 66.0101 Wisconsin Statutes, and other applicable laws, the Village Board of the Village of Summit, Waukesha County, Wisconsin does hereby ordain as follows:

SECTION 1. POLICE COMMISSION MEMBERSHIP REVISED.

Charter Ordinance No. 1-2010, Section 2, Subsection 1.08(D)(2)(a) is hereby revised as follows:

1.08 COMMISSIONS, BOARDS, AND COMMITTEES

- D. Commissions/Boards/Committees Organized
 - 2. Police Commission
 - a. The Police Commission shall consist of five regular members appointed by the Village Board. All of the members shall be residents of either the Village of Summit

or communities contracted for service by the Village of Summit Police Department who do not hold any other elected or appointed office in the Village of Summit.

SECTION 2. SEVERABILITY.

The several sections of this Ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific Section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, Sections or portions thereof of the charter ordinance. The remainder of the charter ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this charter ordinance are hereby repealed as to those terms that conflict.

SECTION 4. EFFECTIVE DATE. This charter ordinance shall take effect 60 days following its passage and publication as provided by Section 66.0101(5), Wisconsin Statutes.
