

ORDINANCE NO.: 15.5



AN ORDINANCE to annex a parcel of land from the Town of Sparta, Monroe County, Wisconsin to the Village of Rockland, Wisconsin.

THE VILLAGE BOARD of The Village of Rockland, La Crosse County, Wisconsin, does ordain as follows:

SECTION I. A proper petition having been presented to the Village Board of the Village of Rockland praying annexation of the following territory, to-wit:

A parcel of land located in part of the SW1/4-NW1/4, Section 31, Township 17 North, Range 4 West, Town of Sparta, Monroe County, Wisconsin:

Commencing at the northwest corner of Section 31, Township 17 North, Range 4 West; thence S00°06′20″E along the west line of the Fractional NW1/4-NW1/4 of Section 31, 1149.63 feet to the Point of Beginning:

Thence N89°33'56"E 1315.04 feet to the East line of the Fractional Wl/2 of the NW1/4;

Thence S00°16'27" E along the East line of the Fractional W1/2 of the NW1/4 662.01 feet to the Northeast comer of Lot 1 of Certified Survey Map (CSM) Volume 11, Page 70 as Document No. 454166;

Thence continuing South along the East line of said Lot 1 of CSM Volume 11, Page 70, to a point of intersection with the north line of a railroad right of way on the southeasterly side of Lot 1 of 11 CSM 70;

Thence southwesterly along said northern railroad right of way line to a point of intersection with the south line of the Fractional W1/2 of the NW1/4, also being the south line of said Lot 1 of CSM Volume 11, Page 70;

Thence west along said south line to the Southwest comer of said Lot 1 of CSM Volume 11, Page 70 to the Southeast comer of Lot 1 of Certified Survey Map Volume 9, Page 99 as Document No. 427218;

Thence West along the south line of CSM Volume 9, Page 99 to the southwest comer of said CSM, point being on the west line of the Fractional W1/2 of the NW1/4;

Thence north along the west line of said CSM Volume 9, Page 99 and west line of the Fractional W1/2 of the NW1/4 to the northwest comer of CSM;

Thence continuing N00°06'20"W along the west line of the Fractional W1/2 of the NW1/4 662.01 feet to the point of beginning.

SECTION II: Payment to the Town of Sparta. Pursuant to Wisconsin Statute §66.0217(14), the Village Board agrees to pay to the Town of Sparta, Monroe County, Wisconsin, annually for five years an amount equal to the amount of property taxes that the Town levied on the annexed territory, as shown by the tax roll under Wisconsin Statute §70.65 in 2013 (the year in which the annexation is final).

SECTION III: EFFECTIVE DATE: This Ordinance shall take effect upon its enactment.

WHEREAS, this annexation will also allow for providing for fire protection by Bangor Burns Rockland ire Department and other applicable Village services as needed; and,

WHEREAS, Rockland Flooring, by and through its owner, Chorney Holdings, LLP, has requested approval om the Town Board of the Town of Sparta, to have its real properties located in said Town to be annexed into the illage of Rockland, La Crosse County, because the Village of Rockland incurs the cost of the damage to the roads and needs the tax revenue from Rockland Flooring to help offset this substantial and continuous expense; and,
