

AN ORDINANCE ANNEXING CERTAIN TERRITORY INTO THE VILLAGE OF HOLMEN (Joseph & Arlone McCabe; Petition MBR#13780)

BE IT ORDAINED by the Village Board of Trustees, Village of Holmen, La Crosse County, Wisconsin as follows:

Section 1.

Pursuant to Section 66.0217(2) of the Wisconsin Statutes and the petition of Joseph & Arlone McCabe, for annexation (Petition MBR#13780) as filed with the Village of Holmen, that certain territory be annexed to the Village of Holmen, La Crosse County, and detached from the Town of Onalaska, La Crosse County, by direct annexation as provided by the Wisconsin Statutes 66.0217(2).

That such territory, as petitioned for annexation, and as described on the attached legal description, Exhibit A, and as shown on the attached scale map, and as reviewed by the Wisconsin Department of Administration and found to be in the public interest, and as is consistent with the <u>Village of Holmen Comprehensive Plan</u>, shall be immediately annexed to the Village of Holmen.

The population of the territory to be annexed is two (2).

Section 2.

That the Zoning Classification for this newly annexed parcel containing 1.42 acres shall be (R-1) Single Family Residential District, and shall be governed by the Holmen Zoning Ordinance.

Section 3.

That this Ordinance is henceforth adopted and passed by a vote of <u>600</u> of the Village Board, at a Village Board meeting on June 12, 2014; and is immediately effective as of this date of passage.
