



CITY OF COLUMBUS ORDINANCE NO. 1/2/3-0/6

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF COLUMBUS, WISCONSIN

The Common Council of the City of Columbus, Wisconsin, do ordain as follows:

SECTION 1. Territory Annexed. In accordance with Sec. 66.0217(2) of the Wisconsin Statutes and the petition for direct annexation filed with the City Clerk on the 1st day of May, 2006 signed by all owners in the territory, there being no electors, the following described property in the Town of Columbus, Columbia County, Wisconsin, is annexed to the City of Columbus, Wisconsin:

See Attached Exhibit A

SECTION 2. Effect of Annexation. From and after the date of this ordinance the territory described in SECTION 1 shall be a part of the City of Columbus, Wisconsin for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Columbus.

SECTION 3. Temporary Zoning Classification.

- (a) The territory annexed to the City by this ordinance is temporarily zoned as RD Rural Development, pursuant to Sec. 66.0217(8)(a) Wis. Stats.
- (b) The Plan Commission is directed to prepare an amendment to the zoning ordinance setting forth permanent classification and regulations for the zoning of the annexed area and to submit its recommendations to the Common Council as soon as shall be convenient.
- SECTION 4. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionally shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 5. Effective Date. This ordinance shall take effect

upon passage and publication as provided by law.




