AN ORDINANCE ANNEXING CERTAIN LANDS OF THE TOWN OF WAUKESHA TO THE CITY OF WAUKESHA, WISCONSIN

THE COMMON COUNCIL OF THE CITY OF WAUKESHA DO ORDAIN AS FOLLOWS: SECTION I. In accordance with Section 66.0217 of the Wisconsin Statutes and petition for annexation filed with the City Clerk on the 12th day of September, 2012, the following described territory in the Town of Waukesha, Waukesha County, Wisconsin is annexed to the City of Waukesha:

Lot 3 Deerfield Estates, being part of the Southwest ¼, Southwest ¼ of the Southeast ¼ of Section 14, Town 6 North, Range 19 East, Town of Waukesha, County of Waukesha, State of Wisconsin.

SECTION II. The above shall be zoned pursuant to the authority granted in Section 66.021(7) of the Wisconsin Statutes as T-1, Temporary Zoning District, C-1 Lowland Conservancy District.

SECTION III. The annexed territory is hereby made a part of the 9th Aldermanic District, and is in the 42rd Ward of the City of Waukesha and is annexed for all municipal purposes including annexation for school purposes and is hereby made a part of the School District of Waukesha, and subject to laws governing the same.

SECTION IV. The City limits of the City of Waukesha, Wisconsin are hereby changed and enlarged as so to include the real estate described in Section I of this ordinance and the official map is amended to include said real estate.

SECTION V. Should any section, paragraph, sentence, clause or phrase of this ordinance be declared unconstitutional or invalid for any reason, the remainder shall not be affected thereby.

SECTION VI. All ordinances or parts of ordinances inconsistent with or contravening the provisions of this ordinance are hereby repealed.

SECTION VII. This ordinance shall be in full force and effect from and after its passage and publication by law.
