The Common Council of the City of Jefferson, Wisconsin, do ordain as follows:

SECTION 1. <u>Territory Annexed</u>. In accordance with Section 66.0217 of the Wisconsin Statutes and the petition for direct annexation filed with the City Clerk on the 7th day of December, 2012, signed by the owners of at least ½ of the land in area and real property in assessed value in the territory, the following described territory in the Town of Jefferson, Jefferson County, Wisconsin, is annexed to the City of Jefferson, Wisconsin:

Part of the SE¼ of the NW¼ of Section 3, T6N, R14E, Town of Jefferson, Jefferson County, Wisconsin, to-wit:

Commencing at an aluminum monument at the W ¼ corner of said Section 3; thence S85°39/24"E, along the E-W ¼ line of said Section 3, 2303.91 feet to the easterly line of the S.T.H. 26 Bypass and the point of beginning; thence continue S85°39/24"E, along said E-W ¼ line, 174.14 feet more or less to the westerly line of the East 153 feet of said SE¼ of the NW¼; thence N0°02'27"E, 694.98 feet more or less to said easterly line of the S.T.H. 26 Bypass; thence S9°26'09"W, 321.99 feet more or less to R/W Monument; thence S18°25'43"W, along said easterly line, 383.85 feet to the point of beginning containing 1.164 acres more or less.

SECTION 2. <u>Effect of Annexation</u>. From and after the date of this ordinance the territory described in section 1 shall be a part of the City of Jefferson for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Jefferson.

SECTION 3. <u>Temporary Zoning Classification</u>. The Plan Commission has recommended a temporary zoning designation of AG (Agriculture).

SECTION 4. <u>Ward Designation</u>. The territory described in Section 1 of this ordinance is hereby made a part of the 5th Ward, District C of the City of Jefferson, subject to the ordinances, rules and regulation of the City of Jefferson governing wards.

SECTION 5. <u>Severability</u>. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provision or application of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 6. <u>Tax Payment</u>. In compliance with Section 66.0217(14)(a) Wis. Stats., the City of Jefferson acknowledges that it must pay annually the Town of Jefferson, for 7 years, an amount equal to the amount of property taxes (\$81.62), that the town levied on the annexed territory, as shown by the 2012 tax roll under Section 70.65 Wis. Stats.

SECTION 7. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.
