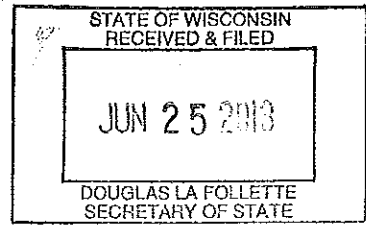

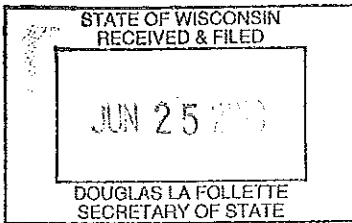

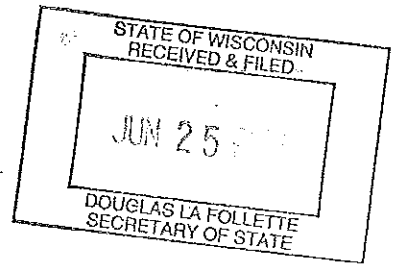

DO ORDAIN as follows:

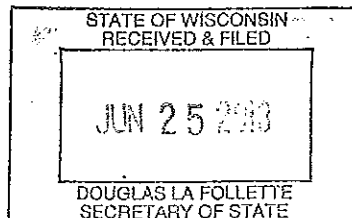

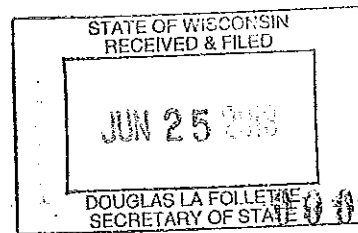

Daniel Korth and Marion Korth, owner of the following described real estate hereby Petitions the Village of Cambridge for annexation as follows:

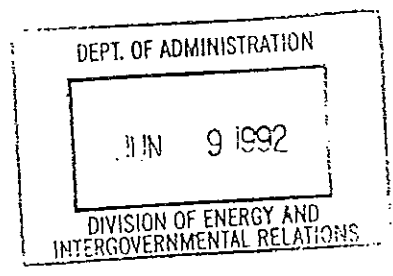
