# AN ORDINANCE ANNEXING TERRITORY OWNED BY THE CITY OF PLYMOUTH FROM THE TOWN OF PLYMOUTH TO THE CITY OF PLYMOUTH PURSUANT TO WIS. STAT. SEC. 66.0223

WHEREAS, the annexation of the following City owned territory located in the Town of Plymouth, Sheboygan County, Wisconsin, more particularly and legally described below and as shown on the Certified Survey Map attached hereto as Exhibit A, to the City of Plymouth, was initiated upon the posting of a Common Council meeting notice indicating that the City was considering enacting an ordinance under Wis. Stat. sec. 66.0223:

Lot One (1) of Certified Survey Map recorded in the Office of the Register of Deeds for Sheboygan County, Wisconsin on February 20, 2002, in Volume 18 of Certified Survey Maps, pages 189/192, Document #1628863, being a part of the Northeast Quarter (NE1/4) of the Northeast Quarter (NE1/4) of Section Twenty-Nine (29), Township Fifteen (15) North, Range Twenty-one (21) East, Town of Plymouth, Sheboygan County, Wisconsin.

NOW, THEREFORE, the Common Council of the City of Plymouth does ordain as follows:

Section 1. Annexation of Territory. The territory described is hereby annexed to the City of Plymouth and shall be included on the City of Plymouth Official Zoning Map and temporarily classified under the Zoning Code in the Agricultural District (A), pursuant to City Municipal Code Section 13-1-21, and the City Clerk/Treasurer is hereby instructed to file immediately with the Secretary of State seven (7) certified copies of this Ordinance together with seven (7) copies of the Certified Survey Map showing the boundaries of the territory attached to the City of Plymouth. The Clerk shall within ten (10) days of filing the certified copies mail or deliver a copy of this Ordinance and the Certified Survey Map with the Sheboygan County Clerk.

Section 2. <u>Effective Date</u>. All ordinances or parts thereof in conflict with the provisions of this Ordinance are hereby repealed to the extent of such conflict, and this Ordinance shall be in effect from and after its passage.


