WHEREAS, The Town Clerk of the Town of Yorkville, Michael McKinney, did, on the 18th day of April, 2018 submit to the Secretary of Administration documents pertaining to the incorporation of the Town of Yorkville as a village under the provisions of §66.0203 (10) Wisconsin Statutes, and the Town Clerk of the Town of Yorkville certified on April 9, 2018 that pursuant to the return of votes cast at the election held and canvassed on April 9<sup>th</sup> 2018, on the question of whether the Town of Yorkville should be incorporated as a village, a majority of the votes were cast in favor of a village as follows:

FOR the village: 1061

AGAINST the village: 54

The territory for incorporation of the Village of Yorkville has an estimated population of 3091 persons

NOW, THEREFORE, I, ELLEN E. NOWAK, Secretary of Administration, pursuant to Wisconsin Statutes 66.0203 (10), do hereby declare that the area, as legally described and shown by map on the following pages and situated in the County of Racine, State of Wisconsin, is duly incorporated as a village and that from henceforth the said village shall be known as the:

and be governed by the provisions of Chapter 66 of the Wisconsin Statutes and Laws amendatory thereof and supplementary thereto.

Dear Ms. Nowak,

Pursuant to Wis. Stats. s. 66.0203(10), the Town of Yorkville held a referendum on April 3, 2018, to ask the electors whether they were for or against incorporation of the town as a village. The unofficial tabulation of votes on April 3, 2018, was 1,060 for a village and 54 against a village. The municipal board of canvass confirmed the official vote tabulation on April 9, 2018, which was 1,061 for a village and 54 against a village.

We are submitting the following information to the Wisconsin Department of Administration and hereby request issuance of a Certificate of Incorporation for the Village of Yorkville:

- 1. Town Clerk's certification of the fact of incorporation and official referendum results based on the canvass held on April 9, 2018.
- 2. Resolution 2018-01 that initiated the referendum process.
- 3. Amended Municipal Board of Canvass election returns
- 4. Four (4) copies of the description of the legal boundaries of the town.
- 5. Four (4) copies of a plat of the town.
- 6. Incorporation fee of One Thousand Dollars (\$1,000.00) payable to the Wisconsin Department of Administration.

By copy of same, we are also sending this letter, the Town Clerk's certification and Town Board Resolution 2018-01 to the Racine County Clerk.

## TOWN OF YORKVILLE RACINE COUNTY, WISCONSIN

#### A RESOLUTION TO INITIATE PROCEDURE FOR INCORPORATING THE TOWN OF YORKVILLE AS A VILLAGE BY PROVIDING FOR A REFERENDUM ON APRIL 3, 2018

THE TOWN BOARD OF THE TOWN OF YORKVILLE, RACINE COUNTY, WISCONSIN, RESOLVES AS FOLLOWS:

WHEREAS, the Town Board of Yorkville ("Town Board"), wishes to allow the electors of the Town of Yorkville the opportunity to determine whether the Town of Yorkville should incorporate and become the Village of Yorkville, as provided by Wis. Stat. § 66.0203(10); and

WHEREAS, the Town Board has verified that the Town of Yorkville meets the requirements for incorporation as a Village pursuant to Wis. Stat. § 66.0203(10), because it is adjacent to the Village of Mount Pleasant which, effective January 1, 2018, contains an electronics and information technology manufacturing zone designated under Wis. Stat. § 238.396(1m); and

WHEREAS, the Town Board previously adopted Resolution No. 2017-10 on November 13, 2017, to initiate the procedure for incorporation of the Town of Yorkville as the Village of Yorkville; and

WHEREAS, the Town Board wishes to confirm and supplement Resolution No. 2017-10 with this Resolution.

#### NOW, THEREFORE, BE IT RESOLVED,

- 1. The Town Board hereby confirms and supplements the procedure for incorporating the Town of Yorkville as the Village of Yorkville pursuant to Wis. Stat. § 66.0203(10), by adopting this Resolution providing for a referendum on the question of whether the Town of Yorkville should become a Village.
- 2. A referendum election shall be held on Tuesday, April 3, 2018, pursuant to Wis. Stat. § 66.0211(3) and Wis. Stat. § 66.0217(7), to the extent applicable. The ballot question on the referendum shall contain the words "for a Village;" and "against a Village."
- 3. The territory which is proposed to be incorporated includes all of the territory located within the boundaries of the Town of Yorkville as it exists as of the date of the referendum election on April 3, 2018. A map of the territory proposed to be incorporated is attached at **Exhibit A** to this Resolution.
- 4. The Town Clerk for the Town of Yorkville is directed to take such actions as are necessary to implement this Resolution and schedule the referendum election.
- 5. The Town Clerk is further directed to post this Resolution on the Town of Yorkville's website and to publish the Resolution as a Class 1 notice pursuant to the provisions of Chapter 985 of the Wisconsin Statutes.

The above Resolution was duly adopted at a meeting of the Town Board of the Town of Yorkville on the 2nd day of January, 2018, by a vote of three in favor and none opposed.




