### AN ORDINANCE TO ANNEX A PARCEL OF LAND IN NE1/4-SE1/4, AND THE SE1/4-SE1/4 SECTION 27, T13N, R6E, FROM THE TOWN OF DELTON, TO THE VILLAGE OF LAKE DELTON, SAUK COUNTY, WISCONSIN

THE VILLAGE BOARD OF THE VILLAGE OF LAKE DELTON, SAUK COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

#### SECTION I. Petition for Direct Annexation.
