## ORDINANCE 2019-1558

# An Ordinance Amending the Charter Ordinance that Establishes the Planning Commission, Enacting Rules for the Reconsideration of Items

THE COMMON COUNCIL OF THE CITY OF MEQUON, OZAUKEE COUNTY, STATE OF WISCONSIN, ORDAINS AS FOLLOWS:

## SECTION I

Charter Ordinance Section IV.03(b) is amended as follows (addition is underlined and deletion is stricken):

(b) At least one of the six citizen members shall be a registered architect. The mayor shall consider nominating as one of the six citizen members, but shall not be required to so nominate, a member of the natural resources boardpark and open space board, or a person with recognized qualifications and experience in landscape architecture, horticulture, environmental science or a similar discipline.

### SECTION II

Charter Ordinance Section IV.04 is amended as follows (additions are underlined and deletions are stricken):

## Sec. IV.04. - Chapter 2, article IX, division 1.

The provisions of chapter 2, article IX, division 1 shall apply to the commission as if fully set forth in this ordinance; however except as follows:

- (a) Notwithstanding any contrary provision of Robert's Rules of Order Revised, as made applicable to the planning commission by section 2-424(e), the following rules of order shall apply:
  - (1) <u>A commissioner voting in the majority may move for reconsideration of a vote, but only at the meeting during which the vote was taken, at the next regular meeting or at a special meeting that precedes the next regular meeting. However, no action of the planning commission shall be subject to a motion to reconsider after material legal rights (other than those rights granted by the planning commission pursuant to the vote) or obligations have arisen resulting from or by virtue of the vote. If a motion to reconsider is timely made, any rights granted by such vote shall be suspended until final action by the planning commission on the motion to reconsider. A motion to reconsider that has been made and lost shall not be renewed.</u>

(2) No measure that has been introduced and lost may be introduced again until the lapse of at least three months from the date of its consideration unless there has been a material change in the application or an intervening event that changes the circumstances originally considered.

(b) Section 2-430 shall not apply.

(c) tTo the extent of any inconsistency between any provision of this ordinance and a provision of chapter 2, article IX, division 1such division, the provision in this ordinance shall govern.

# **SECTION III**

The terms and provisions of this ordinance are severable. Should any term or provision of this ordinance be found to be invalid by a court of competent jurisdiction, the remaining terms and provisions shall remain in full force and effect.

All ordinances and parts of ordinances in contravention to this ordinance are hereby repealed.

#### SECTION V

This is a charter ordinance. It shall take effect 60 days after its passage, postage and publication unless, within such 60-day period, a referendum petition is filed as provided in Wisconsin Statutes Section 66.0101(5), in which event this ordinance will not take effect until it is submitted to a referendum and approved by a majority of the electors voting.
