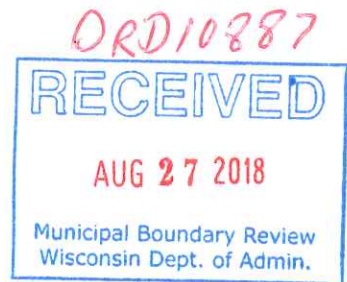

**ORDINANCE 2018-011**

**AN ORDINANCE ATTACHING CERTAIN LANDS LOCATED WEST OF INTERSTATE 39/90/94 AND ALONG THE SOUTHERN HALF OF THE RIGHT-OF-WAY OF STATE HIGHWAY 19 FROM THE TOWN OF BURKE TO THE VILLAGE OF DEFOREST.**

**WHEREAS**, the Village of DeForest entered a cooperative plan pursuant to §66.0307, Wis. Stats. with the Town of Burke in 2006 (the "Cooperative Plan"); and

**WHEREAS**, the Cooperative Plan provides for the transfer of certain lands between the Village of DeForest and Town of Burke; and


**WHEREAS**, the Village and Town have entered into a supplemental agreement specifically authorizing the attachment to the Village of the lands described in Exhibit A; and

**WHEREAS**, the Village Board has determined that the attachment of the lands described and depicted in the scale map attached hereto as Exhibit A to the Village of DeForest will promote the general welfare and orderly development of the Village;

**NOW, THEREFORE**, the Village Board of DeForest, Wisconsin, does ordain as follows:

1. That the lands described and depicted in Exhibit A hereto, are hereby detached from the Town of Burke and attached to, and made a part of, the Village of DeForest as part of the 22nd ward thereof.
2. This ordinance shall take effect the day after its enactment.
3. On and after the effective date of this Ordinance, this territory will be represented by: Congressional District #2, State Senate District #27, Assembly District #79, Court of Appeals District #4, Multi-Jurisdictional Judge #51 and County Supervisory District #21 and shall be part of School District #1316, Technical College District #4.
4. The current population of the annexed territory is zero (0).
5. The Village Clerk shall file, record and send copies of this ordinance and/or a plat of the attached territory as required by §66.0217(9)(a), Wis. Stats.

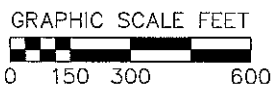
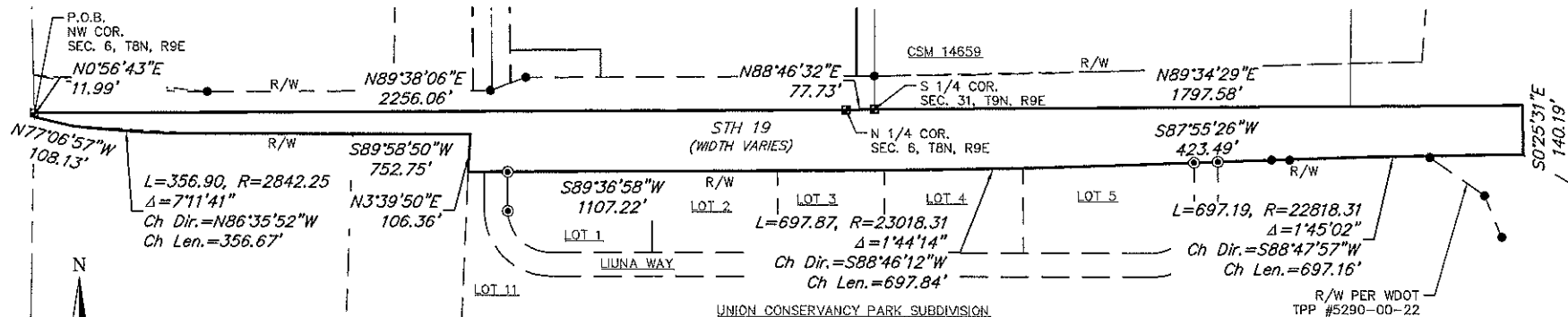

Burke - DeForest Jurisdictional Transfer Description

Located in part of the NE 1/4 of the NE 1/4, the NW 1/4 of the NE 1/4, the NE 1/4 of the NW 1/4 and the NW 1/4 of the NW 1/4 of Section 6, Town 8 North, Range 9 East, all in the Town of Burke, Dane County, Wisconsin.

Commencing at the Northwest corner of said Section 6, Town 8 North, Range 9 East;

Thence N89°38'06"E, along the North line of the NW 1/4 of said Section 6, 2,256.06 feet to the North One-Quarter Corner of said Section 6;

Thence N 88°46'32"E, along the north line of the NE 1/4 of said Section 6, 77.73 feet to the South One-Quarter Corner of Section 31, Town 9 North, Range 9 East;

Thence N89°34'29"E, along the said north line of the NE 1/4 of Section 6, 1,797.37 feet;

Thence S00°25'31"E, 140.19 feet, to the south right-of-way line of Wisconsin State Highway (STH) "19" and a non-tangent arc concave to the south;

Thence 697.19 feet, along said south right-of-way, a non-tangent arc, having a radius of 22,818.31, an included angle of 1°45'02", (a chord of 697.16 feet which bears S88°47'57"W);

Thence S87°55'26"W, continuing along said south right-of-way, 423.49 feet to an arc to the right;

Thence 697.87 feet, along said arc to the right, having a radius of 23,018.31 feet, an included angle of 1°44'14", (a chord of 697.84 feet which bears S88°46'12"W);

Thence S89°36'58"W, continuing along said south right-of-way, 1,107.22 feet;

Thence N03°39'50"E, continuing along said south right-of-way, 106.36 feet to the northeasterly corner of Lot 11 of Union Conservancy Park;

Thence S89°58'50"W, continuing along said south right-of-way, 735.22 feet to an arc to the right;

Thence 356.90 feet, continuing along said south right-of-way, an arc to the right having a radius of 2,842.25 feet, an included angle of 7°11'41", (a chord of 356.67 feet, which bears N86°35'52"W);

Thence non-tangent N77°06'57"W, continuing along said south right-of-way, 108.13 feet to the west line of the NW 1/4 of the NW 1/4 of said Section 6;

Thence N00°56'43"E, along said west line of the NW 1/4 of the NW 1/4, 11.99 feet, returning to the Point of Beginning.

Parcel contains 12.39 Acres, 539,544 Sq. Ft. and is subject to all other easements and rights of way of record.

Bearings are referenced to the Wisconsin County Coordinate System, Dane County, Wisconsin, the north line of the NW 1/4 of Section 6 bears N89°38'06"E.
