RESOLUTION #2022-43

AMENDMENT TO THE 2021-2031 FINAL SUPERVISORY DISTRICT PLAN

WHEREAS, the Vernon County Board of Supervisors approved the 2021-2031 Final Supervisory District Plan dated October 6th, 2021, on November 3rd 2021; and,

WHEREAS, the City of Viroqua, on October 25, 2022, annexed lands located in Supervisory District 12, and created a new Aldermanic Ward 10 to encompass said land; and,

WHEREAS, there are currently three persons living in the new City of Viroqua Ward 10; and,

WHEREAS, in order to have uniform boundaries for Wards and County Supervisory Districts, and to facilitate voting, the City of Viroqua requests that the lands in the newly formed Ward 10, be moved from Supervisory District 12 into Supervisory District 11; and,

WHEREAS, State Stat § 59.10(3)(c)1 reads (*in part*) After the enactment of a plan of supervisory districts under par. (b), the board may amend the plan to reflect a municipal incorporation, annexation, detachment, or consolidation; and

WHEREAS, State Stat § 59.10(3)(c)3 reads (*in part*) An amended plan becomes effective on the first November 15 following its enactment; now, therefore, be it

RESOLVED, that the Vernon County Board of Supervisors approves amending the 2021-2031 Final Supervisory District Plan dated October 6th, 2021, by changing the boundary between Supervisory 11 and Supervisory District 12, so that the newly created City of Viroqua Ward 10 is located in Supervisory District 11; and,

BE IT FURTHER RESOLVED, that the Chairperson of the County Board of Supervisors is directed to file a certified copy of the amended 2021-3031 Final Supervisory District Plan to the secretary of state.
