## ORDINANCE NO. 3678

## AN ORDINANCE ANNEXING PROPERTY TO THE CITY OF FOND DU LAC AND CHANGE LIMITS TO INCLUDE UNDEVELOPED PROPERTY IN THE AREA OF STATE HIGHWAY 23 AND THE WEST SIDE OF COUNTY ROAD K

The City Council of the City of Fond du Lac do ordain as follows:

<u>Section 1</u>. <u>Property Annexed</u>. In accordance with Wisconsin Statutes Section 66.0217 and a Petition for Direct Annexation filed with the City Clerk's office signed by all of the electors residing in the territory proposed to be annexed and the owners of all of the real property in the territory proposed to be annexed, the following described territory, which is contiguous to the City of Fond du Lac, Fond du Lac County, Wisconsin, is hereby annexed to the City of Fond du Lac:

<u>Section 2.</u> The annexation complies with the Cooperative Plan adopted under Wisconsin Statutes Section 66.0307 between the City of Fond du Lac and Towns of Byron, Empire, Fond du Lac, Taycheedah and Friendship in Fond du Lac County and approved by the Wisconsin Department of Administration on July 27, 2017.

<u>Section 3</u>. <u>Effect of Annexation</u>. From and after the date of adoption of this Ordinance, the property described in Section 1 hereof shall be part of the City of Fond du Lac for any and all purposes provided by law, and all persons coming or residing within such property shall be subject to all ordinances, rules and regulations governing the City of Fond du Lac.

Section 4. Ward Designation. The property described in Section 1 is hereby designated and made a part of Ward 17 and the poll location for Ward 17 is the Fond du Lac High School, 601 Campus Drive, Fond du Lac, Wisconsin.

<u>Section 5</u>. <u>Effective Date</u>. This Ordinance shall take effect and be in force upon its passage as provided by law.
