



ORDINANCE NO. 39-20

BY: THE MAYOR

Attaching to the City of Kenosha, Wisconsin, territory in the Town of Paris, Kenosha County, Wisconsin under Section 66.0307, Wisconsin Statutes, City of Kenosha/Village of Somers/Town of Paris State Approved Cooperative Plan:

The Common Council of the City of Kenosha, Wisconsin, does ordain as follows:

Section One: Territory Attached. In accordance with the 2017 City of Kenosha/Village of Somers/Town of Somers/Town of Paris/County of Kenosha/Kenosha Water Utility/Village of Somers Water Utility/Village of Somers Sewerage District/County Highway Commissioner Cooperative Plan and Intergovernmental Agreement under Sections 66.0301, 66.0305, and 66.0307, Wisconsin Statutes, approved by the Wisconsin Department of Administration, Intergovernmental Relations, Municipal Boundary Review, on November 10, 2017, the territory in the Town of Paris, Kenosha County, Wisconsin, with an associated population of none (0), legally described and shown on attached Exhibit "A" and shown on the map attached as Exhibit "B", is hereby attached to the City of Kenosha, Wisconsin, as hereinafter provided.

Section Two: Effect of Attachment. From and after the effective date of this Ordinance, the territory described in Section One shall be a part of the City of Kenosha for any and all purposes provided by law, and all persons coming or residing within such territory shall be subject to all Ordinances, rules and regulations governing the City of Kenosha.

Section Three: Severability. If any provision of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality does not affect the other provisions or application of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.

Section Four: Effective Date. This Ordinance takes effect after passage and publication as provided by law.

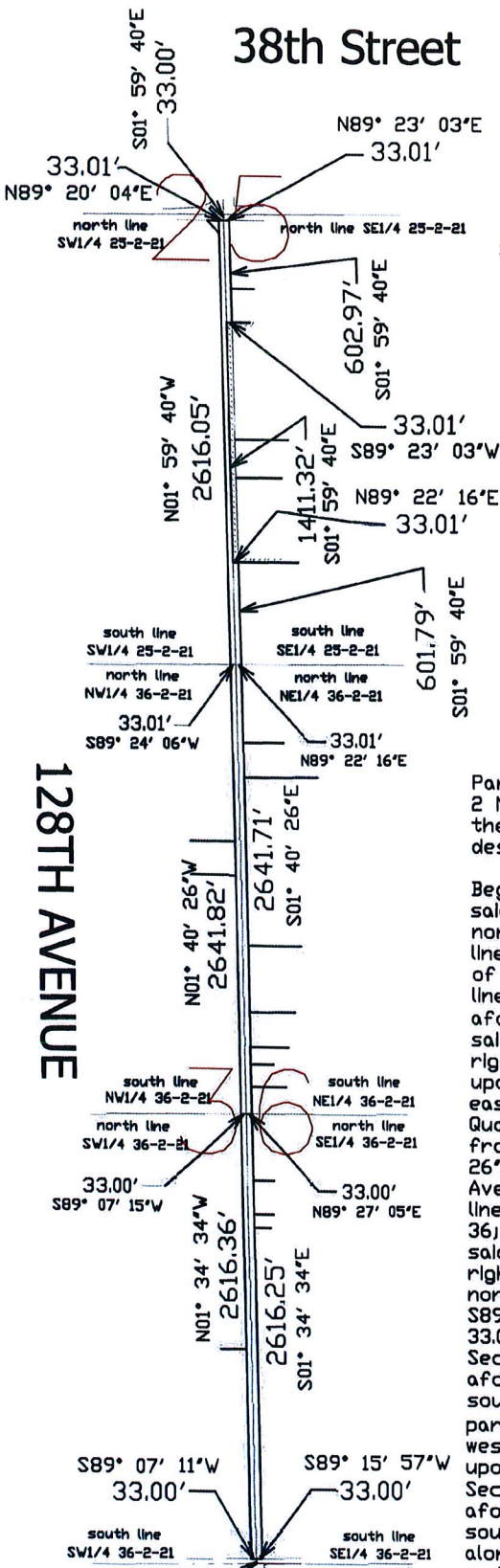
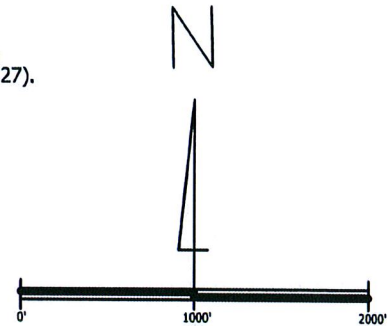

Part of the South Half of Section 25 and all of Section 36, both in Town 2 North, Range 21 East of the Fourth Principal Meridian, lying and being in the Town of Paris, Kenosha County, Wisconsin and being more particularly described as follows:

Beginning at a point on the west line of Southeast Quarter of the aforesaid South Half of Section 25 at a point S01°59'40"E 33.01 feet from the northwest corner thereof; thence N89°23'03"E 33.01 parallel to the north line of said Southeast Quarter Section, 33.01 feet and to the east right of way line of 128th Avenue; thence S01°59'40"E along and upon said east line, 602.97 feet; thence S89°23'03"W 33.01 feet and to the west line of aforesaid Southeast Quarter Section; thence S01°59'40"E along and upon said west line, 1411.32 feet; thence N89°22'16"E 33.01 feet and to the east right of way the aforesaid 128th Avenue; thence S01°59'40"E along and upon said east line, 601.79 feet and to the south line of aforesaid Southeast Quarter Section, which line is also the north line of the Northeast Quarter of aforesaid Section 36; said point being N89°22'16"E 33.01 feet from the northwest corner said Quarter Section; thence continue S01°40'26"E along and upon the east right of way line of aforesaid 128th Avenue, 2641.71 feet and to the south line of said Quarter Section, which line is the north line of the Southeast Quarter of the aforesaid Section 36; said point being N89°27'05"E 33.00 feet from the northwest corner of said Quarter Section; thence continue S01°34'34"E along and upon the east right of way line of the aforesaid 128th Avenue, 2616.25 feet and to the north right of way line of County Trunk Highway "K" (60th Street); thence S89°15'57"W on the extension of said north right of way line westerly, 33.00 feet and to the west line of the aforesaid Southeast Quarter Section, which line is also the east line of the Southwest Quarter of the aforesaid Section 36; said point being N01°34'34"W 33.00 feet from the southeast corner of said Quarter Section; thence continue S89°07'11"W parallel to the south line of said Quarter Section, 33.00 feet and to the west line of the aforesaid 128th Avenue; thence N01°34'34"W along and upon said west line, 2616.36 feet and to the north line of said Quarter Section, which line is also the south line of the Northwest Quarter of aforesaid Section 36, said point being S89°07'15"W 33.00 feet from the southeast corner of said Quarter Section; thence continue N01°40'26"W along and upon the west line of the aforesaid 128th Avenue, 2641.82 feet and to the north line of said Quarter Section, which line is also the south line of the Southwest Quarter of the South Half of the aforesaid Section 25; said point being S89°24'06"W 33.00 feet from the southeast corner of said Quarter Section; thence N01°59'40"W along and upon the west line of the aforesaid 128th Avenue, 2616.05 feet; thence N89°20'04"E parallel to the north line of said Quarter Section, 33.01 feet and to the point of beginning. Containing 10.86 acres, more or less. Subject to easements and restrictions of record.
