ORDINANCE NO. OR21-03

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF BRILLION, WISCONSIN

The Common Council of the City of Brillion, Wisconsin, do ordain as follows:

SECTION 1. Territory Annexed. In accordance with sec. 66.0217(2) (2) of the Wisconsin Statutes and the petition for unanimous and direct annexation filed with the City Clerk on the 15th day of September, 2021, signed by all the owners of the land in area in the territory, the following described territory in the Town of Brillion, Calumet County, Wisconsin, is annexed to the City of Brillion, Wisconsin:

SECTION 2. Effect of Annexation. From and after the date of this ordinance the territory described in Section 1 shall be a part of the City of Brillion for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Brillion.

SECTION 3. Zoning Classification. Upon recommendation of the Plan Commission, the territory annexed to the city of Brillion by this ordinance is zoned Commercial Highway (C2), pursuant to sec. 66.0217(8)(a) of the Wisconsin Statutes.

SECTION 4. Ward Designation. The territory described in Section 1 of this ordinance is hereby made a part of the Ward 4 of the City of Brillion, subject to the ordinances, rules and regulations of the City of Brillion governing wards.

SECTION 5. Severability. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

SECTION 6. Effective Date. This ordinance shall take effect upon passage and publication as provided by law.


