ORDINANCE NO. 20-2021

AN ORDINANCE ANNEXING CONTIGUOUS TERRITORY TO THE CITY OF BEAVER DAM PURSUANT TO WIS. STATS. SEC. 66.0217(2) (ANNEXATION BY UNANIMOUS APPROVAL)

THE COMMON COUNCIL OF THE CITY OF BEAVER DAM DO ORDAIN AS FOLLOWS:

SECTION I: Section 1-14 of the Municipal Code is hereby amended by annexing the territory as described and shown on the documents attached hereto marked Exhibits "A" (Annexation Legal) and "B" (Annexation Map) and made a part hereof:

Direct annexation from the Town of Beaver Dam to the City of Beaver Dam of 22.45 acres of vacant land being Tax Parcel No. 004-1214-2741-000, being all of Lot 1 of Certified Survey Map 3417 and part of the Northeast 1/4 of the Southeast 1/4, Section 27, Township 12 North, Range 14 East, in the Town of Beaver Dam, Dodge County, Wisconsin.

Said parcel being located on Ollinger Road, and as petitioned by Rose Anne Callies by her Financial Power of Attorney, Randall R. Callies.

SECTION II: Said parcel, upon its annexation, will be added to existing Ward 13 in the City of Beaver Dam.

SECTION III: There is one (1) resident living on the property to be annexed.

SECTION IV: Said parcel, upon its annexation, is hereby zoned R-1 Single Family Residential District pursuant to Sec. 70-84 of the Municipal Code.

SECTION V: Said ordinance shall be effective upon its passage on November 15, 2021, and publication on November 20, 2021.



Commencing at the Northeast corner of the Southeast 1/4 of Section 27, Township 12 North, Range 14 East, thence South 89°48'14" West along the North line of the Southeast 1/4 of said Section 27, a distance of 579.58 feet to the point of beginning of the hereinafter described lands; thence South 00°32'45" East along the West line of Lot 2 of Certified Survey Map 3417 and the extension thereof a distance of 1333.28 feet to the Centerline of Ollinger Road; thence South 89°41'49" West along the centerline of said Ollinger Road, 733.24 feet; thence North 00°32'46" West along the East line of Certified Survey Map 5341 and Certified Survey Map 5945 a distance of, 1334.65 feet to a point on the North line of said Southeast 1/4 of Section 27; thence North 89°48'14" East along said North line of the Southeast 1/4, a distance of 733.25 feet to the point of beginning.
