WHEREAS, the Common Council has determined that the City has reasonable need for the property and it is in the best interest of the petitioners, the residents and owners of property in the area to be annexed and the City of Manitowoc to annex the property after reviewing the recommendations of the Wisconsin Department of Administration pursuant to Wis.
