SECTION 1. Territory Annexed. In accordance with sec. 66.0223 of the Wisconsin Statutes and annexation of territory owned by the Village by ordinance enacted by the Village Board, the following described territory in the Town of Grantsburg, Burnett County, Wisconsin, is annexed to the Village of Grantsburg, Wisconsin:

Lot 2 of Certified Survey Map No. 4851, Volume 27, pages 109 & 110, Document #455190 located in part of the Northwest Quarter of the Southwest Quarter of Section 11, Township 38 North, Range 19 West, Town of Grantsburg, Burnett County, Wisconsin.

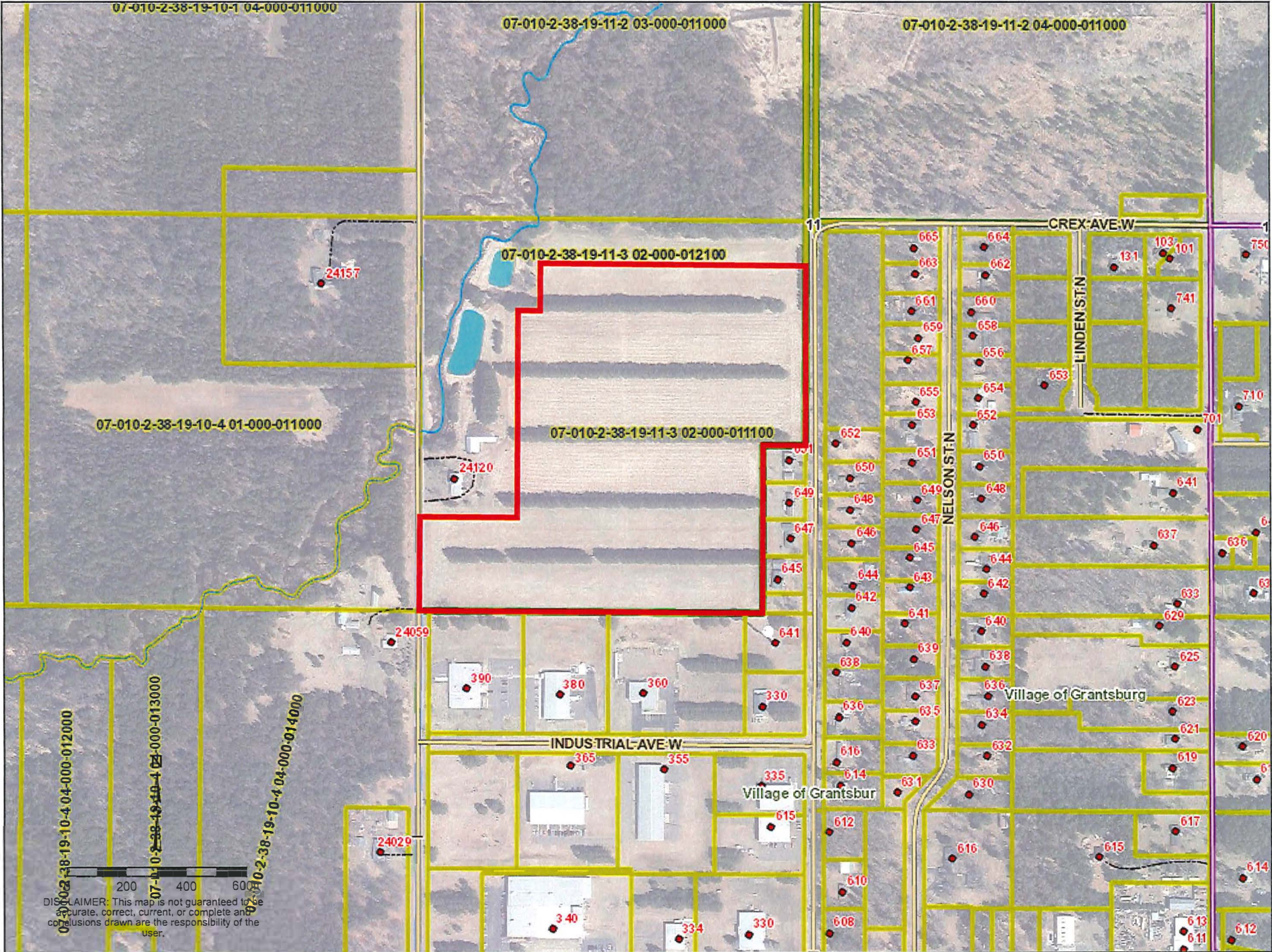
