An Ordinance to Annex Land to the  
Village of Cross Plains, Dane County,  
Wisconsin Pursuant to Wis. Stats. Section  
66.0217(2).

The Board of Trustees of the Village of  
Cross Plains does hereby ordain as follows:

1. The Village of Cross Plains (“Owner”) is the owner of real property currently situated within the Town of Cross Plains, and more particularly described on the attached Exhibit A and as shown on the Exhibit B scale map.
2. The land owned by the Owner as described on the attached Exhibit A is contiguous to the Village of Cross Plains on the Village’s northern boundary.
3. On January 4, 2002, Owner filed a Petition for Annexation by unanimous approval with the Village of Cross Plains for the Exhibit A land pursuant to Section 66.06271(2) Stats.
4. The real property described on Exhibit A is currently vacant land, and contains no residents or electors.
5. The exact legal description of the territory to be detached from the Town of Cross Plains and annexed to the Village of Cross Plains is attached hereto as Exhibit A and contains 0.611 acres.
6. The property described on Exhibit A which is presently located in the Town of Cross Plains, is hereby annexed from the Town of Cross Plains to the Village of Cross Plains. The population of the area being annexed is zero. The annexed territory will join an existing ward and not necessitate the creation of a new ward.
7. The land being annexed shall be permanently zoned as set forth in a separate Ordinance adopted by the Village Board of the Village of Cross Plains.





Pursuant to Section 66.0217(14) the Village agrees to pay annually to the Town, for five years, an amount equal to the amount of property taxes that the Town levied on the annexed territory as shown by the tax roll under Section 70.65, Stats. beginning in the year in which the annexation is final.
9. All ordinances or parts of ordinances inconsistent with or contradicting a provision of this ordinance is hereby repealed.
10. This ordinance shall be in full force and effect from and after its passage and posting.




LANDS TO BE ANNEXED TO THE VILLAGE OF CROSS PLAINS

LEGAL DESCRIPTION

A parcel of land located in the NE1/4 of the NW1/4 of Section 2, T7N, R7E, Town of Cross Plains, Dane County, Wisconsin to-wit: Commencing at the North 1/4 of said Section 2; thence S00°47'23"W, 1286.64 feet along the North/South line of said Section 2; thence N88°12'58"W, 1304.25 feet to the point of beginning; thence N88°12'58"W, 28.53 feet to a point on the West line of said NE1/4 of the NW1/4; thence N01°00'47"E, 663.70 feet; thence S89°24'27"E, 44.31 feet to the Southwest corner of Lot 2, Certified Survey Map No. 4886, also being on the East right-of-way line of Military Road; thence S01°16'37"W, 380.44 feet along said East right-of-way line; thence S03°50'30"W, 284.31 feet along said East right-of-way line to the point of beginning. Containing 26,604 square feet (0.611 acres).


