ORDINANCE NO. 23-1023

Wisconsin Dept. of Administration AN ORDINANCE ANNEXING THE HEREIN DESCRIBED PROPERTY TO THE CITY OF VERONA, DANE COUNTY, WISCONSIN

The Common Council of the City of Verona, Dane County, State of Wisconsin, by at least a two-thirds (2/3) vote of its members, does hereby ordain as follows:

Section 1. **Territory Annexed.**

In accordance with Section 66.0217 of the Wisconsin Statutes the following described territory contiguous to the City of Verona and located in the Town of Verona, Dane County, Wisconsin is hereby annexed to the City of Verona:

Legal descriptions as surveyed in the Town of Verona, Dane County, State of Wisconsin

LANDS TO BE ANNEXED TO THE CITY OF VERONA

Part of the NEI/4 of the SWI/4, part of the NWI/4 of the SWI/4, and part of the SWI/4 of the NWI/4 of Section 9, and part of the SEI/4 of the NE1/4 of Section 8, all in Township 6 North, Range 8 east, Town of Verona, Dane County, Wisconsin, containing 3,402,456 square feet (78.1096 acres) described as follows:

Commencing at the northwest corner of said Section 9; Thence along the west line of the NWI/4 of said Section 9, S 00°44'20"W, 1529.19 feet to the point of beginning; Thence S 88° 02' 20" E. 983.98 feet to the west line of Northern Lights Road right-of-way as recorded in volume 60-064B of plats page 347, as document no. 5274778; Thence along said west right-of-way line, S 01° 15' 49" E, 33.05 feet; Thence continuing along said west right-of-way line, S 88° 02' 20" E, 248.39 feet; Thence continuing along said west right-ofway line. S 11° 43' 57" E. 152.22 feet: Thence continuing along said west right-of-way line, S 00° 00' 04" E, 50.00 feet; Thence continuing along said west right-of-way line, S 27° 54' 45" E, 39.67 feet; Thence continuing along said west right-of-way line, S 00° 09' 36" W. 863.39 feet to the west line of Northern Lights Road right-of-way as recorded in Volume 60-064B of plats page 346, as document no. 5274777; Thence along said west right-ofway line, S 00° 08' 35" E, 1327.38 feet to the north line of Lot 11 Epic 2; Thence along said north line, N 88° 26' 20" W, 1315.06 feet to an easterly line of said Lot 11; Thence along said easterly line continuing along the west line of the NW1/4 of the SW1/4 of said Section 9, N 00° 44' 18" E, 1331.24 feet to the WI/4 corner of said Section 9; Thence along the west line of the SW1/4 of the NW1/4 of said Section 9, N 00° 44' 18" E, 223.59 feet to a corner of Lot 1 CSM 9782; Thence along a line of said Lot 1, N 89° 22' 12" W, 420.01 feet to a corner of said Lot 1; Thence along a line of said Lot 1, N 00° 44' 20" E, 527.30 feet to a corner of said Lot 1; Thence along a line of said Lot 1, S 89° 22' 12" E, 371.54 feet to a corner of said Lot 1; Thence along a line of said Lot 1, N 00° 44' 20" E. 117.73 feet to a corner of said Lot 1; Thence S 89° 22' 12" E, 48.47 feet to the west line of the SW1/4 of the NW1/4 of said Section 9; Thence along said west line, N 00° 44' 20" E, 264.59 feet to the point of beginning.

Said parcel is contiguous to the City of Verona, subject to any and all easements and/or right-of-ways of record. Said parcel contains zero (0) electors and has a population of zero (0).

Section 2. Effect of Annexation.

From and after the date of this Ordinance, the territory described in Section 1 shall be a part of the City of Verona, Dane County, Wisconsin for any and all purposes provided by law and all persons coming to or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Verona. Per Chap. 66.0217(14)(a)1 the City of Verona agrees to pay annually to the Town of Verona, for five (5) years, an amount equal to the amount of property taxes that the Town of Verona levied on the annexed territory, as shown on the tax roll under s. 70.65, in the year in which the annexation is final.

Section 3. Temporary Zoning Classification.

Upon recommendation by the Plan Commission, the territory annexed to the City of Verona by this Ordinance is temporarily designated to be a part of the following district of the City for zoning purposes and subject to all provisions of the zoning ordinance of the City of Verona relating to such district classification and to zoning in the City: Rural Agriculture.

Section 4. Voting Districts.

The territory annexed in the vicinity of Northern Lights Road shall be within the following voting districts:

- (a) Aldermanic District No. 2
- (b) Ward No. 15 (new ward)
- (c) Dane County Supervisory District No. 32

Section 5. <u>Severability</u>.

If any provision of this Ordinance is invalid or unconstitutional, or if the application of this Ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this Ordinance which can be given effect without the invalid or unconstitutional provision or application.

Section 6. Effective Date.

This Ordinance shall be effective and the territory described in Section 1 shall be considered annexed to the City of Verona upon publication as required by law and upon execution of an annexation agreement.
