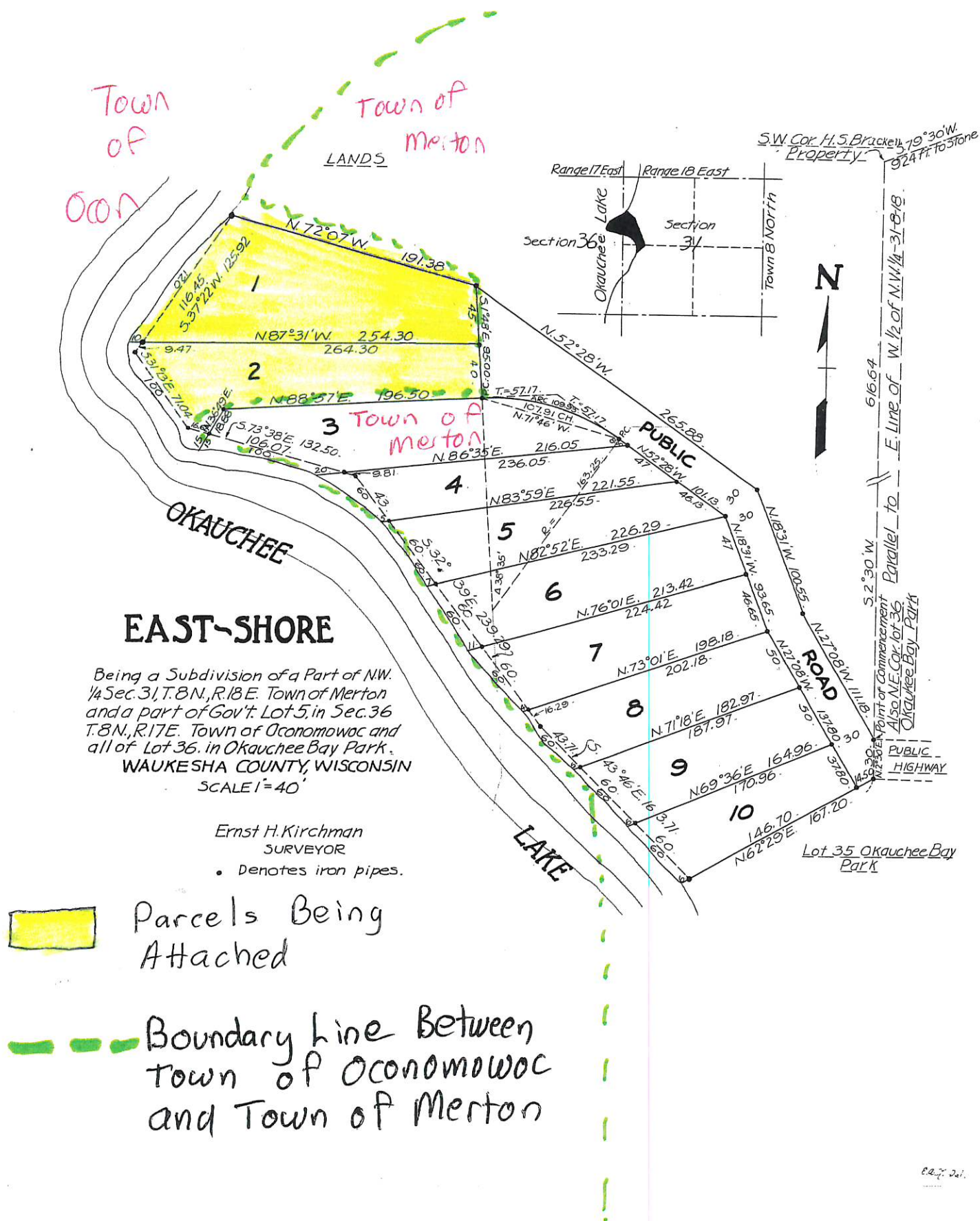

ORDINANCE NO 2023-11

AN ORDINANCE PROVIDING FOR DETACHMENT OF A PORTION OF THE TOWN OF OCONOMOWOC, WAUKESHA COUNTY, WISCONSIN, TO THE TOWN OF MERTON, WAUKESHA COUNTY, WISCONSIN PURSUANT TO COOPERATIVE PLAN.

WHEREAS, the Town of Oconomowoc and Town of Merton entered into a Cooperative Plan pursuant to Wis. Stat. § 66.0307, which was subsequently approved by the State of Wisconsin Department of Administration on (the “Cooperative Plan”);

WHEREAS, Section 3.1 of the Cooperative Plan provides for the detachment of certain territory located in the Town of Oconomowoc to be attached to the Town of Merton;

WHEREAS, this Ordinance is intended to serve as the detachment Ordinance for such lands; and

NOW, THEREFORE, the Town Board of the Town of Oconomowoc, Waukesha County, Wisconsin does ordain as follows:

SECTION 1. Pursuant to Wis. Stat. § 66.0307 and the Cooperative Plan between the Town of Oconomowoc and Town of Merton, the lands described and depicted on the attached Exhibit A shall be detached from the Town of Oconomowoc, and attach to, and included in the boundaries of, the Town of Merton effective as of January 1, 2024.

SECTION 2. The Town of Oconomowoc Clerk shall deliver and file all documents required under Wis. Stat. §§ 66.0217(9) and 66.0307(10), and take all other necessary action in order to implement his ordinance.

SECTION 3: All ordinances or parts of ordinance conflicting or contravening the provisions of this Ordinance are hereby repealed.

SECTION 4: This Ordinance shall take effect upon passage and posting or publication as provided by law.

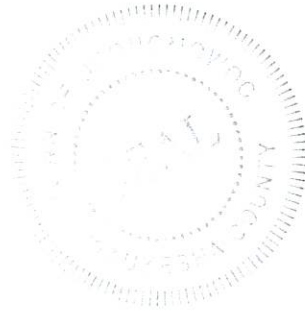

AN ORDINANCE PROVIDING FOR ATTACHMENT OF A PORTION OF THE TOWN OF OCONOMOWOC, WAUKESHA COUNTY, WISCONSIN, TO THE TOWN OF MERTON, WAUKESHA COUNTY, WISCONSIN PURSUANT TO COOPERATIVE PLAN.

WHEREAS, the Town of Oconomowoc and Town of Merton entered into a Cooperative Plan pursuant to Wis. Stat. § 66.0307, which was subsequently approved by the State of Wisconsin Department of Administration (the "Cooperative Plan");

WHEREAS, Section 3.1 of the Cooperative Plan provides for the detachment of certain territory located in the Town of Oconomowoc to be attached to the Town of Merton;

WHEREAS, this Ordinance is intended to serve as the attachment Ordinance for such lands; and




