AN ORDINANCE PROVIDING FOR THE DIRECT ANNEXATION BY UNANIMOUS APPROVAL OF A PORTION OF THE TOWN OF DUNN TO THE CITY OF STOUGHTON, DANE COUNTY, WISCONSIN

#### RECITALS

- Daniele St. Marie Thompson on behalf of Greenbriar Farms Limited Partnership Α. ("Owner") who owns land in the Town of Dunn as described in Exhibit A and shown in Exhibit B (the "Territory") and is seeking to annex the Territory by unanimous approval to the City of Stoughton, pursuant to Wis. Stat. § 66.0217(2).
- В. The City of Stoughton Plan Commission has recommended that the Territory be annexed to the City, and that the Territory be assigned a temporary zoning classification of RH - Rural Holding.
- C. The proposed annexation has been reviewed by the Wisconsin Department of Administration and found to be in the public interest.
- The population of the proposed land is 0. D.
- E. The annexation represents approximately 33.708 acres from the Town of Dunn.

NOW, THEREFORE, the Common Council of the City of Stoughton, Dane County, Wisconsin, does ordain as follows:

#### ORDINANCE

- 1. <u>Recitals</u>. The above recitals are material to and are incorporated in this Ordinance.
- 2. <u>Territory Annexed</u>. The Territory is annexed by unanimous approval to the City of Stoughton pursuant to Wis. Stat. § 66.0217(2).
- 3. <u>Effect of Annexation</u>. From and after the effective date of this ordinance, the Territory shall be a part of the City of Stoughton for any and all purposes provided by law, and all persons coming or residing within such Territory shall be subject to all ordinances, rules, and regulations governing the City of Stoughton.
- 4. <u>Town Taxes</u>. Pursuant to §66.0217(14)(a)1., Wis. Stats., the City agrees to pay annually to the Town of Dunn for 5 years, an amount equal to the amount of property taxes that the town levied on the annexed territory, as shown by the tax roll under §70.65 Wis. Stats., in the year in which the annexation is final.
- 5. <u>Temporary Zoning Designation</u>. The Territory shall be temporarily zoned R-H Rural Holding.
- 6. <u>Ward Designation</u>. The Territory shall be added to <u>Ward No. 8</u> of the City of Stoughton.
- 7. <u>Clerk Duties</u>. The City Clerk is hereby directed to publish notice of and provide copies of this Ordinance in accordance with the applicable Wisconsin Statutes.
- 8. <u>Effective Date</u>. This ordinance shall take effect upon passage and publication as provided by law.

#### RECITALS

- The Common Council enacted Ordinance O-25-2023 on August 8, 2023 by which A. it annexed certain lands from the Town of Dunn.
- В. Ordinance O-25-2023 designated the annexed lands as part of Ward 8 of the City, but said lands are located in a different county supervisory district from Ward 8. requiring that a new ward be created.
- C. The Common Council intends by this Ordinance to amend only that portion of Ordinance O-25-2023 designating the voting ward of the annexed territory to correctly reference a new Ward 9 instead of Ward 8.

NOW, THEREFORE, the Common Council of the City of Stoughton, Dane County, Wisconsin, does ordain as follows:

#### **ORDINANCE**

- 1. Recitals. The above recitals are material to and are incorporated in this Ordinance.
- 2. <u>Correction to Ward Designation</u>. Paragraph 6 or Ordinance O-25-2023 is hereby amended to read as follows:

"Ward Designation. The Territory is hereby designated as a new Ward No. 9 of the City of Stoughton."

- 3. <u>Ratification</u>. Except as provided in paragraph 2, Ordinance O-25-2023 shall remain in effect without change.
- 4. <u>Clerk Duties</u>. The City Clerk is hereby directed to publish notice of and provide copies of this Ordinance in accordance as required by the applicable Wisconsin Statutes.
- 5. <u>Effective Date</u>. This ordinance shall take effect upon passage and publication as provided by law.
