CITY OF MARINETTE ORDINANCE NO. 2530

AN ORDINANCE ANNEXING TERRITORY OWNED BY THE CITY OF MARINETTE FROM THE TOWN OF PESHTIGO INTO THE CITY OF MARINETTE, MARINETTE COUNTY, WISCONSIN

The Common Council of the City of Marinette ordains as follows:

WHEREAS, the City of Marinette owns right-of-way property located in the Town of Peshtigo; and

WHEREAS, Wis. Stat. § 66.0223 specifies the procedure for the annexation of territory owned by the City;

NOW, THEREFORE, the Common Council of the City of Marinette, Wisconsin, do ordain as follows:

SECTION 1. The City of Marinette hereby annexes the following right-of-way property from the Town of Peshtigo, which is more specifically described as:

Part of Government Lots 2 and 3 of Section 17, T30N, R24E, Town of Peshtigo, Marinette County, Wisconsin.

Commencing at the West ¼ corner of said Section; thence N 88° 14' 59" E along ¼ line, a distance of 33.01 feet to the East line of Shore Drive; thence N 00° 10' 48" W along said line, a distance of 5.00 feet to a point on the North line of University Drive and the **POINT** OF BEGINNING; thence N 88° 14' 59" E along said line, a distance of 893.58 feet; thence S 00° 05' 27" W along the Easterly line of University Drive, a distance of 5.00 feet to the North line of University Drive; thence N 88° 22' 38" E along said line, a distance of 419.27 feet to the Northwesterly line of University Drive; thence N 62° 50' 24" E along said line, a distance of 163.68 feet; thence S 17° 51' 11" E, a distance of 73.49 feet to the Southeasterly line of University Drive; thence S 26° 16' 27" W along said line, a distance of 71.38 feet to the Southerly line of University Drive; thence S 88° 22' 31" W along said line, a distance of 446.35 feet; thence S 88° 41' 25" W along said line, a distance of 163.87 feet; thence S 88° 13' 35" W along said line, a distance of 147.62 feet; thence S 88° 40' 57" W along said line, a distance of 481.43 feet; thence S 88° 26' 05" W along said line, a distance of 209.58 feet to a point on the East line of Shore Drive; thence N 00° 26' 57" W along said line, a distance of 57.84 feet; thence N 00° 10' 48" W along said line, a distance of 5.00 feet to the POINT OF BEGINNING; said described tract containing 2.30 acres (100,240.23 square feet), more or less

(the "Annexed Territory"). See Exhibit A "Annexation Map" document.

Said annexation shall detach the Annexed Territory from the Town of Peshtigo and annex the same to the City of Marinette.

SECTION 2. The City Clerk is hereby directed to file a copy of this ordinance and exhibits with the secretary of administration. The annexation of the Annexed Territory shall be effective upon the ordinance's adoption.

SECTION 3. Upon the annexation of the territory described in SECTION 1 to the City of Marinette, such lands shall be included in Ward 3, and the City Clerk will file with the county clerk or board of election commissioners the report required by Wis. Stat. Section 5.15(4)(b).

SECTION 4. That the above-described annexed property prior to annexation was part of the Marinette School District and such territory shall remain part of said School District.

SECTION 5. Within ten (10) days of filing the certified copies with the secretary of administration under Section 2 of this Ordinance, the City Clerk is directed to mail or deliver a copy of the ordinance and exhibits to the clerk of Marinette County.

SECTION 6. The terms and provisions of this ordinance are severable. Should any term or provision of this ordinance be found to be invalid by a court of competent jurisdiction, the remaining terms and provisions shall remain in full force and effect.

SECTION 7. This ordinance shall take effect upon its adoption by the Common Council.

BE IT RESOLVED that the foregoing ordinance be adopted and shall become effective on passage.


