VILLAGE OF HOWARD ORDINANCE NO.2024-08

AN ORDINANCE ANNEXING TERRITORY OWNED BY THE VILLAGE OF HOWARD FROM THE TOWN OF PITTSFIELD INTO THE VILLAGE OF HOWARD, BROWN COUNTY, WISCONSIN

The Village Board of the Village of Howard ordains as follows:

WHEREAS, the Village of Howard owns parcels of property in the Town of Pittsfield, Brown County Tax Parcel Numbers PI-653 and PI-654-1; and

WHEREAS, Wis. Stat. § 66.0223 specifies the procedure for the annexation of territory owned by the Village;

NOW, THEREFORE, the Village Board of the Village of Howard, Wisconsin, does ordain as follows:

SECTION 1. The Village of Howard hereby annexes Brown County Tax Parcel Numbers PI-653 and PI-654-1 from the Town of Pittsfield, which is more specifically described as:

THE NORTHWEST QUARTER OF THE SOUTHEAST QUARTER (SE 1/4 OF SE 1/4), AND PART OF THE SOUTHWEST 1/4 OF THE SOUTHEAST 1/4, SECTION THIRTY-FIVE (35), TOWNSHIP TWENTY-FIVE (25) NORTH, RANGE NINETEEN (19) EAST, IN THE TOWN OF PITTSFIELD, BROWN COUNTY, WISCONSIN, DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTH 1/4 CORNER OF SECTION 35, T25N-R19E; THENCE N00°22'03"W, 2652.54 FEET ALONG THE WEST LINE OF THE SOUTHWEST 1/4 OF SAID SECTION; THENCE N85°07'27"E, 1310.85 FEET ALONG THE NORTH LINE OF THE NORTHWEST 1/4 OF THE SOUTHEAST 1/4 OF SAID SECTION; THENCE S00°39'26"E, 2648.28 FEET ALONG THE EAST LINE OF SAID QUARTER-QUARTER AND THE EAST LINE OF THE SOUTHWEST 1/4 OF THE SOUTHEAST 1/4 OF SAID SECTION; THENCE S84°59'05"W, 993.45 FEET ALONG THE SOUTH LINE OF SAID SOUTHWEST 1/4 OF THE SOUTHEAST 1/4; THENCE N00°22'03"W, 275.91 FEET ALONG DOCUMENT #2881464, BROWN COUNTY RECORDS; THENCE S84°59'05"W, 300.99 FEET ALONG THE NORTH LINE OF SAID DOCUMENT; THENCE S00°22'03"E, 275.91 FEET ALONG THE WEST LINE OF SAID DOCUMENT TO THE SOUTH LINE OF SAID QUARTER-QUARTER; THENCE S84°59'05"W, 30.10 FEET ALONG SAID LINE TO THE POINT OF BEGINNING.

BOUNDARY CONTAINS 3,399,186 SQUARE FEET / 78.03 ACRES, MORE OR LESS. (the "Annexed Territory"). See Scale Map attached.

Said annexation shall detach the Annexed Territory from the Town of Pittsfield and attach the same to the Village of Howard.

SECTION 2. The Village Clerk is hereby directed to file seven (7) certified copies of this ordinance and exhibits with the secretary of administration. The annexation of the Annexed Territory shall be effective upon such filing.

SECTION 3. Upon the attachment of the Annexed Territory to the Village of Howard, such lands shall be included in Ward 22, and the Village Clerk will file with the county clerk or board of election commissioners the report required by Wis. Stat. Section 5.15(4)(b).

SECTION 4. That the above-described annexed property prior to annexation was part of the Pulaski School District and such territory shall remain part of said School District.

SECTION 5. Within ten (10) days of filing the certified copies with the secretary of administration under Section 2 of this Ordinance, the Village Clerk is directed to mail or deliver a copy of the ordinance and exhibits to the clerk of Brown County.

SECTION 6. The terms and provisions of this ordinance are severable. Should any term or provision of this ordinance be found to be invalid by a court of competent jurisdiction, the remaining terms and provisions shall remain in full force and effect.

SECTION 7. This ordinance shall take effect upon its adoption by the Village Board.

BE IT RESOLVED that the foregoing ordinance be adopted and shall become effective on passage and filing with the secretary of administration.


