ORDINANCE NO. 3867

AN ORDINANCE ANNEXING 2016 E. BRADLEY STREET FROM THE TOWN OF TURTLE TO THE CITY OF BELOIT

The City Council of the City of Beloit, Rock County, Wisconsin, do ordain as follows:

Section 1. Territory Annexed. In accordance with Section 66.0217(2) of Wisconsin Statutes and the *Petition for Direct Annexation* filed by Emily Davis with the City Clerk on the 30th day of January 2025, signed by all of the owners of real property of the following described property in the Town of Turtle, Rock County, Wisconsin, the following territory is annexed to the City of Beloit, Wisconsin:

LOT 42, BLOCK 8, LINDALE PLACE, BEING PART OF THE SOUTHWEST ¼ OF THE SOUTHWEST ¼ OF SECTION 19, TOWN 1 NORTH, RANGE 13, EAST OF THE 4TH P.M., TOWN OF TURTLE, ROCK COUNTY, WISCONSIN.

DESCRIBED AS FOLLOWS: COMMENCING AT THE WEST ¼ CORNER OF SECTION 19, TOWN 1 NORTH, RANGE 13 EAST, OF THE 4TH P.M.; THENCE SOUTH 0°26′05″ WEST ALONG THE WEST LINE OF SECTION 19 AFORESAID A DISTANCE OF 1783.10 FEET; THENCE SOUTH 89°31′10″ EAST A DISTANCE OF 598.27 FEET TO THE NORTH CORNER OF LOT 42 OF BLOCK 8, LINDALE PLACE, BEING THE POINT OF BEGINNING OF LANDS HEREINAFTER DESCRIBED; THENCE SOUTH 44°44′38″ EAST ALONG THE EASTERLY LINE OF AFORESAID LOT 42 A DISTANCE OF 125.00 FEET; THENCE SOUTH 45°09′08″ WEST ALONG THE SOUTHEASTERLY LINE OF AFORESAID LOT 42 A DISTANCE OF 50.00; THENCE NORTH 44°44′38′ WEST ALONG THE SOUTHWESTERLY LINE OF AFORESAID LOT 42 A DISTANCE OF 125.00 FEET TO THE SOUTHEASTERLY RIGHT-OF-WAY LINE OF BRADLEY STREET; THENCE NORTH 45°09′08″ EAST ALONG THE AFORESAID SOUTHEASTERLY RIGHT-OF-WAY LINE OF BRADLEY STREET; THENCE NORTH 45°09′08″ EAST ALONG THE AFORESAID SOUTHEASTERLY RIGHT-OF-WAY LINE OF BRADLEY STREET A DISTANCE OF 50.00 FEET TO THE POINT OF BEGINNING. CONTAINING 0.144 ACRES, MORE OR LESS.

Section 2. Effect of Annexation. From and after the date of this Ordinance the territory described in Section 1 shall be part of the City of Beloit for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all Ordinances, rules, and regulations governing the City of Beloit.

Section 3. Payment to Town of Turtle. The City of Beloit agrees to pay the Town of Turtle, for five (5) years, an amount equal to the annual amount of property taxes levied on the annexed territory by the Town of Beloit as shown on the Town of Turtle's tax roll prepared pursuant to Section 70.65 Wisconsin Statutes.

Section 4. Ward Designation. The territory described in Section 1 of this Ordinance is hereby made a part of the <u>Twenty-ninth (29th) Ward</u> of the City of Beloit, subject to the Ordinances, rules, and regulations of the City, governing ward districts.

Section 6. Severability. If any provision of this Ordinance is invalid or unconstitutional, or if the application of this to any person or circumstance is invalid or unconstitutional, such invalidity or

unconstitutionality shall not affect the other provisions or applications of this Ordinance, which can be given effect without the invalid or unconstitutional provision or application.

Section 7. Effective Date. This Ordinance shall take effect and be in force upon its passage and publication.
