ORDINANCE NO. 7574

ORDINANCE ANNEXING TERRITORY TO THE CITY OF EAU CLAIRE.

THE CITY COUNCIL OF THE CITY OF EAU CLAIRE DOES ORDAIN AS FOLLOWS:

<u>Section 1.</u> <u>Territory Annexed.</u> In accordance with Section 66.0217(2) of the Wisconsin Statutes, the following described territory in the Town of Washington, Eau Claire County, Wisconsin, by unanimous consent is annexed to the City of Eau Claire, Wisconsin.

AIM COMMERCIAL REAL ESTATE ANNEXATION (Petition #14741) Town of Washington

Part of the Northwest of the Southeast, the Northeast of the Southeast, the Southeast, the Southeast of the Southeast, and the Southeast of the Southeast of Section 1, Township 26 North, Range 9 West, Town of Washington, Eau Claire County, Wisconsin.

Commencing at the East Quarter Corner of said Section 1;

<u>Section 3.</u> <u>Zoning Classification</u>. The territory annexed to the City of Eau Claire by this ordinance is designated to be C-3 Community Commercial District for zoning purposes and subject to all provisions of the zoning ordinance of the City of Eau Claire relating to such district classification and to zoning in the city.

Section 4. Ward Designation. The territory described in Section 1 of this ordinance is hereby made a part of the 15th Assessment Ward, the 2nd Aldermanic District of the City of Eau Claire, and Voting Ward 80. of the City of Eau Claire, subject to all ordinances, rules and regulations of the city governing wards and districts.

<u>Section 5.</u> <u>Severability</u>. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such

invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be given effect without the invalid or unconstitutional provisions or applications.


