ORDINANCE ANNEXING TERRITORY TO THE CITY OF EAU CLAIRE.

THE CITY COUNCIL OF THE CITY OF EAU CLAIRE DOES ORDAIN AS FOLLOWS:

<u>Section 1</u>. <u>Territory Annexed</u>. In accordance with Section 66.0217(2) of the Wisconsin Statutes, the following described territory in the Town of Washington, Eau Claire County, Wisconsin, by unanimous consent is annexed to the City of Eau Claire, Wisconsin.

CHAPUT ANNEXATION (Petition #14743) Town of Washington

LOCATED IN THE SOUTHWEST ¹/₄ OF THE NORTHWEST 1/4, SECTION 1, TOWNSHIP 26 NORTH, RANGE 9 WEST, TOWN OF WASHINGTON, EAU CLAIRE COUNTY, WISCONSIN, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE WEST QUARTER CORNER OF SAID SECTION 1;

THENCE N 02⁰21' 22" E, 42.89 FEET MORE OR LESS, TO NORTH RIGHT OF WAY OF OLD TOWN HALL ROAD,

THENCE S 87^o51' 40" E, 1078.77 FEET ALONG THE NORTH RIGHT OF WAY OF OLD TOWN HALL ROAD TO THE POINT OF BEGINNING;

THENCE N 01⁰29' 39" E, 420.67 FEET, MORE OR LESS, TO SOUTHERLY RIGHT OF WAY LINE OF INTERSTATE 94;

<u>Section 2.</u> <u>Effect of Annexation</u>. From and after the date of this ordinance, the territory described in Section 1 shall be part of the City of Eau Claire for any and all purposes provided by law and all persons coming or residing within such territory shall be subject to all ordinances, rules and regulations governing the City of Eau Claire.

<u>Section 3.</u> <u>Zoning Classification</u>. The territory annexed to the City of Eau Claire by this ordinance is designated to be C-3 Community Commercial District for zoning purposes and subject to all provisions of the zoning ordinance of the City of Eau Claire relating to such district classification and to zoning in the city.



The territory described in Section 1 of this ordinance is hereby made a part of the 15th Assessment Ward, the 2nd Aldermanic District of the City of Eau Claire, and Voting Ward 79. of the City of Eau Claire, subject to all ordinances, rules and regulations of the city governing wards and districts.

<u>Section 5.</u> <u>Severability</u>. If any provision of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or application of this ordinance which can be given effect without the invalid or unconstitutional provisions or applications.
