AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF LANCASTER, GRANT COUNTY, WISCONSIN

WHEREAS, the Common Council of the City of Lancaster previously adopted Ordinance Number 2023-06 annexing the property described in the attached Exhibit A; and

WHEREAS, the attached Exhibit A to Ordinance Number 2023-06 contained an omission in the legal description for Parcel 2; and

WHEREAS, the Map of the Property submitted to the Wisconsin Department of Administration for the Ordinance Number 2023-06 did not meet the required guidelines; and

WHEREAS, the Common Council of the City of Lancaster desires to correct the errors in Ordinance Number 2023-06 and hereby readopts said annexation ordinance to correct those errors.

NOW, THEREFORE, The Common Council of the City of Lancaster, Grant County, Wisconsin, do ordain as follows:

SECTION 1. Territory Annexed. In accordance with Wis. Stats. Sec. 66.0223, the following property, more particularly described below, located in the Town of South Lancaster, Grant County, Wisconsin, is annexed to the City of Lancaster, Wisconsin:

SECTION 2. Effect of Annexation.
